Public Comment:

Ethan Brandt shared his disappointment with Supervisor Udy in regards to the US Fish and Wildlife Permit requesting the Board remove Dave Udy as permit administrator. Marvin Bolton shared his support for the Northpoint swimmer's itch plans noting his comparisons between Northpoint and Sicon reports. Tom Kizer shared his concerns about the misconduct of Supervisor Udy in requesting an amendment to USFWS permit. Steve Sendek gave a synopsis and clarification of the Northpoint Program requesting that the slanderous statements of their program stop. Martha Clapp spoke of the integrity and honesty of Supervisor Udy. Ken Dennings referred back to the letter given on behalf of the HLPOA, HLSIO, HLEEC, HLLC requesting the the Board end the lethal take program and remove artificial nesting boxes. Ken Dennings also gave the Board an email document and stated there was no authority to take eggs, young or adult birds from duck boxes. Chuck Brick referred to the letter written by the DNR requesting that the duck boxes be taken down. Tom Mutchler said nest boxes were never allowed questioned the liabilities involved and laws being broken. Bill Baker noted duck nesting boxes were used in Harvey Blankenspoor's program in 1990. Ethan Brand referred to the misrepresentation used on the permit amendment request. Jean Lawrence referenced that the Board had already chosen the direction to go with the permit.

Request was made to the Board by Jason Garvon, Ph.D from Lake Superior State University. Samples will be used for research focus on parasites commonly found in the liver of waterfowl along with an ongoing project to screen for avian schistosomes using molecular (DNA) methods as well as screening for Leucocytozoans, Plasmodium sp. and Haemorpoteus sp.
