## *Gerrish Township Police Monthly Report 05-01-16 through 05-31-16*

The Gerrish Township Police Department responded to a total of 131 calls for service for the month of May 2016.

The Department reports 4 custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 23 total citations listing 18 traffic violations, 2 misdemeanor citations, 4 custodial arrests and 7 verbal warnings for the month. (See attached for breakdown).

### Training:

54 training hours are reported this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I coordinated and assisted with seasonal training for the State Park Officers held here at GTPD.
- 2) I participated with ACT-NOW in the Annual Spring road clean-up project which encompasses Pioneer Hill to Hillsdale Dr on Co Rd 100.
- 3) I attended the Gerrish Township work session as required.
- 4) I attended the ACT-NOW Executive Board meeting in my Advisory role.
- 5) I attended the Northern Michigan Children's Assessment Center team case review meeting on behalf of the Department.
- 6) I attended two AVI Meetings regarding the planning of the Charlton Heston Academy all County AVI exercise planned for August 2016.
- 7) I coordinated and attended a CERT planning team meeting for the 2<sup>nd</sup> Quarter Search and Rescue training.
- 8) I attended the regular Gerrish Township Board meeting as required.
- 9) I held a staff meeting this month covering several topics of importance for summer enforcement concerns.
- 10) I met with the Roscommon County Sheriff and MEEMIC insurance company reference "The Boot" program and the Roscommon Are Public Schools. This item will harden the target of classroom doors in the event of an AVI at the schools.
- 11) I met separately with the Bittersweet Lane dock association regarding the improper placement of a dock to resolve the issue. The issue was resolved without enforcement of Public Act 56.

- 12) I attended the ACT-NOW Community Meeting with this month's topic being the History of Gerrish Township presented by Dan Fishel, local Historian.
- 13) I attended the LEPT monthly meeting as a member of same.
- 14) I attended the Roscommon Area Public Schools meeting regarding the presentation of "The Boot" program and viewed the presentation of Rob Courtier of the "Lockdown Company".
- 15) I provided Incident Command and coordinated the 2<sup>nd</sup> Quarter Search and Rescue training for our CERT Team and members of the Sheriff's Dept. Auxiliary. There were two different simultaneous search and rescues at two different locations to practice Operation commands at multiple locations. All objectives and goals were met for the training.
- 16) I met individually with the Sheriff to brainstorm bullet points for a program brochure for "Adopt a door."
- 17) I attended the Roscommon County Community Corrections Authority Board meeting in my board member capacity to discuss the new grant submission and future programs.
- 18) I attended a Friends for Safe School meeting to further formalize the funding streams, RCCF fund discussion and "Adopt a Door" program materials.
- 19) I attended a meeting at the Roscommon County Central Dispatch with the Motorola Corporation regarding the end of support on December 31, 2018 for the current 700/800 MHZ XTS 5000 models of portable and mobile radios. Our Department radios are in the planned phase out and will no longer be able to be supported by Motorola. They are launching their next generation APX 6000 radios. Our County is looking at becoming a "pilot" County for some consideration on pricing on the new models at a discounted rate. This meeting is the first of many planned to discuss the feasibility and offers to reduce the price of the radio replacement in the County. Our current Radios are 12 years old.
- 20) I attended the Roscommon County Law Enforcement Administrators meeting at the Fred's Restaurant in Roscommon, MI. While there, we worked on the staffing commitments for a return to the South Higgins Lake State Park youth alcohol enforcement effort on the 4<sup>th</sup> of July Weekend. I also have authored an Operations Plan for the event to include many partners to safely conduct the effort.

Highlights this month for the Department include;

We had a busy Memorial Day weekend overall and the staff here handled things very well.

GTPD, GTFD/EMS, CERT, ACT NOW and the Roscommon County Road Commission are having a coordination meeting in June to correlate services for the annual Higgins Lake Sunrise Run. Organizers have provided us with a route for this years run to include the 13.1 half marathon, 10k and 5k. Preparations for all the deployments are being made for the run scheduled Saturday June 18, 2016. We will be assisted by MSP and the Sheriff's office along the route of the 13.1 marathon.

As a reminder again, there will not be a June ACT NOW community meeting in lieu of ACT NOW's participation in the June 18, 2016 Higgins Lake Sunrise Run.
