Gerrish Township Police Monthly Report 07-01-16 through 07-31-16

The Gerrish Township Police Department responded to a total of 210 calls for service for the month of July 2016.

The Department reports 72 total citations recording 37 traffic violations, 38 Misdemeanor violations and 20 written verbal warnings. (See attached report for breakdown).

The Department also reports 17 custodial arrests for the monthly period. (See attached report for breakdown).

Training:

The Department reports 30 hours of training this month. (See attached breakdown)

Chief Hill highlighted activity for the reported month is as follows:

- 1) I provided Incident Command and authored the operational plan for the 2016 South Higgins Lk State Park Youth Alcohol Enforcement effort which took place on July 2 and 3 2016 from 1400 hrs to 2200 hrs.
- 2) I met with the planning commission for the purposes of discussing the Medical Marijuana legislative status and to review a proposed Medical Marijuana facility zoning ordinance adoption.
- 3) I attended the Gerrish Township Board monthly work session to brief same on our Department activities this past month.
- 4) I attended the ACT-NOW Executive Board in my Advisory role.
- 5) I prepared the 2017-2018 Police Department budget for review at the Gerrish Township Budget work session in preparation for an August 15, 2016 public hearing to approve the special assessment.
- 6) I prepared the June Monthly Board Reports as required.
- 7) I coordinated the up fitting of the new Patrol unit to include graphics etc.
- 8) I chaired the 911 Technical Board meeting in my chairperson capacity.
- 9) I chaired the Roscommon County Law Enforcement Wrecker committee meeting which is a subdivision of the 911 Technical board to hear a wrecker service grievance and request for change of coverage area.
- 10) I attended the Gerrish Township Regular Board meeting as required.

- 11) I attended a Task Force Investigators meeting in West Branch, MI on behalf of the Department in coordination with an on-going breaking and entering of storage units in Northern Michigan.
- 12) I presided over two Staff meetings this month.
- 13) I attended the two Roscommon County AVI meetings preparing for an exercise at the Charlton Heston Academy in St. Helen, MI. on August 25, 2016.
- 14) I met with some Sovereign Park residents regarding Lake Dr use discussing the court governing of the area of the Abandoned Lake Dr.
- 15) I attended the NMCAC monthly team meeting representing our Department in discussing our CSC and abuse/neglect files.
- 16) I attended the ACT-NOW Annual Meeting and Block Party held at the Gerrish Township Pavilion on July 18, 2016. At the meeting I conducted the Annual elections of office process to place an Executive board for the 2016 and 2017 fiscal year. This year's Citizen of the year Award went to Carmine Polisei of GAP #2. A plaque was also given to Al Schultz of GAP 3 for 17 years of service to our Executive board, most of his service was a Co-Chair of the board. He will be missed as Al was an original board member of ACT-NOW.
- 17) I met with the Michigan Municipal League Risk manager for the Meadowbrook Company who is our Workman's Compensation/ Off Duty Disability Carrier. The Department received a good review with no suggestions for further limiting the liability. The Department has had no loss of work claims in 5 years and therefore our rating factor will decrease yet again for the upcoming year.
- 18) I attended the Roscommon County Law Enforcement Administrator's lunch meeting held at Fred's Restaurant and discussed various Law Enforcement issues.
- 19) I met with Northern Sealcoating for the purposes of obtaining an estimate for a Township wide sealcoating to reseal, fill cracks and re-paint the various Township Facilities parking areas. Additionally, an estimate was made for the re-sealing of the Cemetery drives as well.
- 20) I attended the 700.800 MHZ meeting to hear products available by 3 different companies to replace our County's antiquated mobile and portable radios which are due to be losing support on December 31, 2018.
- 21) I attended a Bud Bash 2016 Law Enforcement Coordination meeting held at the MSP #72 Post. The operations plan was discussed as well as scheduling and personnel coverage for the August 5th and 6th event.
- 22) In the month of July, we have been changing out our flooring that served us since the original construction of the building. The project should be complete on August 6, 2016.
- 23) In the Technology area, the Department has gone to a total Office 365 product in order to gain seamless schedule sharing via our Network and computer stations as well as seamless integration into our cell devices. The transition is complete as of this writing. Additionally, we have changed our domain name on our email addresses to gerrishpolice.org.

In other news;

We are happy to announce that Carmine Polisei was named as Citizen of the Year by ACT-NOW and the Gerrish Township Police Department. Carmine received a congratulatory plaque for his outstanding committed service to this Community. Carmine is new to ACT-NOW and we have found him to be very energetic in Community Service and surely gave the group a great shot in the arm this past year. He has proven to be an excellent resource in fundraising and is definitely in touch with our Township as he represented GAP 2 on the Executive Board and was elected as our Co-Chair for the 2016-2017 fiscal year. We applaud and thank Carmine and could never repay him for his valuable service to the Township.

We received notification from Al Schultz, longtime ACT-NOW Executive Board member and Co-Chair that he was retiring as of the Annual meeting 2016. Al has served for 17 years and was an original board member and has seen the organization grow from the first \$500.00 grant from Michigan State University to what it has grown into today. We thank him for his interest in the Community and will certainly miss his participation in ACT-NOW's decisions.
