Gerrish Township Police Monthly Report 08-01-16 through 08-31-16

The Gerrish Township Police Department responded to a total of 132 calls for service for the month of August 2016.

The Department reports 7 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 18 total citations listing 19 traffic violations, 9 misdemeanor charges, 6 verbal traffic warnings. (See attached for breakdown).

Training:

A total of 90 hours of training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended two Friends for Safe Schools meetings working on "The boot" funding and discussion of coordination of kick off for the fundraising campaign of "Adopt a Door".
- 2) I authored a Roscommon Rotary grant application as the coordinating person requesting \$15,000.00 for the Friends for Safe Schools.
- 3) I attended the monthly Gerrish Township Board work session as required.
- 4) I attended the ACT-NOW Executive Board meeting in my advisory board member role.
- 5) I coordinated all flooring and carpeting installation with the bid winner, The Floor Store of Houghton Lake and all flooring has been completed.
- 6) I chaired and attended the 911 Technical Board meeting held at Roscommon County Central Dispatch.
- 7) I attended the Gerrish Township Regular Board meeting as required.
- 8) I attended the Roscommon County AVI committee meeting to further finalize the all-County AVI exercise plan at the Charlton Heston Academy in St. Helen, Mi. which took place on 8-25-16.
- 9) In discussions with Sheriff Stern, I arranged for and oversaw the Deputization of all Officers of our Department to further solidify our relationship and mutual aid availability.
- 10) I met with the CERT 3rd Quarter Training planning team where we designed a "Fun Run" concept to train. We will be covering the following topics; Incident Command, Radio etiquette and training, Fire Safety, Splinting and Initial Patient Survey, Outdoor Search and

Rescue, Indoor Search and Rescue, Triage, First Aid, CPR and wounds and bandaging. The event will take place on 10-8-16 from 10:00 a.m. to 3:00 p.m.

- 11) I was away from the Department on Annual leave for 10 days to care for my wife who was recovering from ankle replacement surgery.
- 12) I prepared a final budget for presentation at the Special Assessment Budget Hearing for the 2017-2018 fiscal budget. Due to my absence, Sgt Patchin presented my finished budget at the meeting.
- 13) On August 18, 2016 I met with Mike Morin who is our Risk Control Representative from the Michigan Township Participating Plan where we had a site review as well as policy review. During that review, I was advised that they wished us to draft policy on Handling of Mentally Ill individuals and an ADAAA policy to address Americans with Disabilities that may be arrested.
- 14) I conducted one staff meeting this month to cover a myriad of issues, concerns and case file management discussion.
- 15) I met with Attorney Hess on several case files that were ready for civil remedy this month. Additionally, I am working with the Zoning and Building Department regarding working a case to a condemnation attempt via court process.
- 16) Sgt Patchin and I attended the Roscommon Middle School open house where we manned a table explaining the roll out of the Adopt a Door program as it relates to "The Boot Project" providing the mechanism to all doors at our school campus.

In other news;

The Department participated in the 7th Annual ACT-NOW/GTPD Golf Outing held at the Redwood Country Club on August 13, 2016 and the event generated \$3800.00 for the group for its benevolent contributions to our Community. Thank you to all that participated in golfing, volunteering or sponsoring the event.
