Gerrish Township Police Monthly Report 04-01-16 through 04-30-16

The Gerrish Township Police Department responded to a total of 140 calls for service for the month April 2016. (See attached report for breakdown).

The Department reports 11 custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 26 total citations listing 19 traffic violations, 10 misdemeanor violations, and 2 written verbal warnings for the month. (See attached for breakdown).

Training:

29 continuing education contact training hours are reported this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the regular Township board work session as required and presented many topics for review by the board.
- 2) I attended and presented a Legislative update and power point regarding Medical Marihuana, Marihuana legalization efforts and an overview of the State of Colorado after a few years of experience with recreational marihuana in place to the Gerrish Township Planning Commission on request.
- 3) I attended the MACP Legislative Board meeting in my capacity as a representative of Northern Lower Michigan, via teleconference.
- 4) I attended a safety and security meeting targeted at boosting the safety at our local Roscommon Area Public Schools with a door barricade product.
- 5) I hosted and attended a CERT Planning meeting for the purposes of organizing our 2nd Quarter CERT training exercise.
- 6) I attended and chaired the Roscommon County 911 Technical Board meeting in my Chair person capacity.
- 7) I participated in a training session at the Fire Department/EMS regarding Radio desk functions to volunteer at the desk when needed.
- 8) I attended the LEPT meeting held at the Roscommon County Commissioners room.

- 9) I attended the graduation of the First class of the Roscommon County Sobriety Court.
- 10) I have met twice this month with the Houghton Lake Floor Store who I have contracted with to consult about options for replacing the 18 year old flooring at the Police Department. Additionally, an RFP has come out the process for future bid packages to be obtained to complete the job in 2016.
- 11) I have conducted one staff meeting this month where all Officers have been trained in firearms re-familiarization and range rules in anticipation of our up-coming spring 2016 qualification range day.
- 12) I attended the monthly Roscommon County Law Enforcement Administrator's meeting held at Fred's Restaurant in Roscommon, Mi.
- 13) I attended the Northern Michigan Children's Assessment Center monthly team meeting on behalf of the Department.
- 14) I attended the ACT-Now Executive Board meeting in my Advisory role to the group.
- 15) The Department turned over 35.8 lbs. of unwanted prescription pills to the Tip of the Mitt Watershed council at the Petoskey Department of Public Safety.

Highlights for April:

ACT-NOW and the Police Department have agreed once again to partner on the "Scrap Metal Project." You may drop off items of scrap and ACT-NOW will dispose of same and the use of the funds will be for Community projects to include scholarships at the local High School, Shop with a Cop, winter heating assistance for the elderly, etc.

The ACT-NOW trailer is placed next to the impound lot and ready for people to drop off their metal in the trailer.

The Gerrish Township Police, "Team Torch" captured its second straight Dodgeball Championship at the 2nd Annual tournament to benefit the Northern Michigan Assessment Center which provides child forensic interviews and victim advocate services to abused and/or neglected children in our four county area. The tournament is a fundraiser and made just over \$800.00 this year. The event was held at the Houghton Lake High School.
