### ***Gerrish Township Police Monthly Report 02-01-19 through 02-28-19***

The Gerrish Township Police Department responded to a total of 108 calls for service for the short month of February 2019.

The Department reports 5 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 14 total citations listing 11 traffic violations, 6 Misdemeanor violations and 3 verbal warnings issued for the month. (See attached for breakdown).

#### **Training:**

A total of 64 contact hours of training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) Lt Patchin and I attended the Michigan Association of Police Chiefs mid-winter conference and took various training classes available.
- 2) I attended the regular Gerrish Township Board meeting as required.
- 3) I attended the ACT-NOW Executive Board meeting in my advisory board member capacity to plan activities to benefit our community in 2019.
- 4) I attended the Michigan Association of Chiefs of Police Legislative Committee while at the conference mentioned above where I reported out on my three bill assignments, all dealing with Carrying a Concealed Weapon proposed law changes. We also discussed many other pending legislative pieces to affect Law Enforcement. Stances are developed and communicated to the Legislators.
- 5) I also attended the Northern Michigan Association of Chiefs of Police meeting discussing local issues and providing Legislative update for the MACP to the group.
- 6) I met with the COOR Superintendent Shawn Petri and Roscommon County Emergency Manager Mike Beaty this month to assist him with security concerns and strategy to "harden the target" of his Administrative building as it relates to active shooter situations. He is considering re-configuring

their entry at the Administrative building and we left him with a template to begin the Emergency Management plans for the entire campus. He advised that he would like continued discussions as they go through their template and update their emergency plans.

7) I was elected chair of the 911 Technical Board meeting for the 2019-2020 year. This is a position I have held for many years. At this month's meeting, we were given for review at our next meeting proposed policy changes to the Law Enforcement related policies for 2019.

8) I facilitated a CERT 1<sup>st</sup> quarter training revolving around communication, our freshly donated 800 MHz radios and their operation to include training on the 800 MHz digital truncated system. Additionally we had our annual bag check and a review of the Active 911 system and sign up for the service for call outs.

9) I facilitated and attended a department staff meeting for review and construction of our 2019-2021 Organizational and Operational goals.

10) All the Officers and myself attended a training presented by the Northern Michigan Children's Assessment Center held at the Denton Township Ambulance Training Room. The training was entitled Adverse Childhood Experiences (ACE) which is a program designed to learn about Trauma and its effect on children and the need to intervene in the cycle. We also were asked to participate in a "Handle with Care" approach to children that have had trauma and to communicate same to a key school identified person so they may be able to help the child through the day as necessary if needed. Additionally, we were given the protocols and details of the new Sexual Assault Nurse Examiner resources available now locally for our investigations.

11) I chaired a Grayson's Gift monthly meeting in my interim chair role as we move forward on the identification and installation of the bed shakers for the hard of hearing population.

12) This month I worked on a power point presentation to present to the public at a public hearing for the review of the materials being proposed for the adoption of the International Property Maintenance Code by reference and a subsequent Rental Registration ordinance. The power point was to frame a focused discussion at the hearing

13) I presented the above power point presentation and attended the public hearing referred to above. Our Property Maintenance Committee will be meeting to consider the input received in suggestion or comments and further correct drafts as necessary for future recommendation to the Township Board for consideration.

14) I hosted a meeting of Administrator's for the purposes of hearing a presentation by Blake Davis from the Northern Michigan Law Enforcement Training Group which operates out of Camp Grayling. The group has a partnership with the Camp for base use of certain areas and facilities. We reviewed Training available as well as discussed current needs and delivery models to accommodate back fill but yet make training goals in a more convenient fashion.

15) As a member of the Insurance benefits committee for the Township, I attended a meeting with Clerk Patchin and our current carrier representative Dale Boehm of Boehm-Tarrant Associates to discuss his proposals for the 2019-2020 Insurance year regarding Health/RX, Vision and Dental Benefits.

16) The Department participated in Lockdown Drills at the Roscommon Area Public Schools Campus at their request.
