### ***Gerrish Township Police Monthly Report 03-01-17 through 03-31-17***

The Gerrish Township Police Department responded to a total of 107 calls for service for the month of March 2017.

The Department reports 9 various custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 37 total citations listing 40 traffic violations, 6 misdemeanor cited violations, 23 verbal warnings for the month. (See attached for breakdown).

#### Training:

The Department reports 60 Hours of continuing education training contact hours. (See attached document).

Chief Hill highlighted activity for the reported month as follows:

- 1) I attended the Gerrish Township Annual, Regular, and General Budget meetings.
- 2) I arranged for and attended a webinar by PMAM which is a software vendor that supplies a solution for use that would assist in the Accreditation process currently under review by this Department through the Michigan Association of Chiefs of Police.
- 3) I participated in the evaluation of Officers of this Department to secure goals and performance objectives for the 2017-2018 Calendar year.
- 4) I participated in the Gerrish Township Fire/EMS Family night held this past month.
- 5) I attended one Gerrish Township Board work session/Department Head meeting.
- 6) I attended the ACT NOW Monthly Executive Board meeting this month.
- 7) The Police Department made the Police Department garage available to accommodate Fire Fighter State testing.
- 8) I assisted in arranging and attended an awards presentation to Officer Norm LaBonte at the Roscommon County Courthouse Building where he received a life-saving award from Sheriff Ed Stern. Dep Quintana also received a life saving award at that time.
- 9) Additionally, I presented Officer LaBonte with a Department Police Citation for his work for the same event that occurred in June of 2016.
- 10) I conducted one staff meeting this month and much of same was dedicated to discussing Health Benefit proposed changes and other case review as normal for the meetings.

- As a reminder, the April Community meeting for ACT-NOW is scheduled for Monday, April 17, 2017 at 7:00 p.m. The presentation this month will be an update on what has taken place over the winter months in crime in your Township.
