Gerrish Township Police Monthly Report 05-01-17 through 05-31-17

The Gerrish Township Police Department responded to a total of 122 calls for service for the month of May 2017.

The Department reports 8 custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 32 total citations listing 30 traffic violations, 6 misdemeanor citations, 8 custodial arrests and 13 verbal warnings for the month. (See attached for breakdown).

Training:

60 training hours are reported this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I coordinated and assisted with seasonal training for the State Park Officers held here at GTPD.
- 2) I participated with ACT-NOW in the Annual Spring road clean-up project which encompasses Pioneer Hill to Hillsdale Dr on Co Rd 100.
- 3) I attended the Gerrish Township work session as required.
- 4) I attended the ACT-NOW Executive Board meeting in my Advisory role.
- 5) I attended the Northern Michigan Children's Assessment Center team case review meeting on behalf of the Department.
- 6) At the request of the 911 Director, I sat on the panel to interview for hire a prospective 911 Dispatcher.
- 7) The Department and ACT-NOW were at the Roscommon High School Awards night and presented two \$1000.00 scholarships to two graduating seniors of the Roscommon High School.
- 8) I attended the regular Gerrish Township Board meeting as required.
- 9) I attended the Sons of the American Revolution awards ceremony at the Roscommon County Commissioners Chamber while Officer LaBonte was honored for his life saving actions in June of 2016.
- 10) I have been down to the Reeves Forest/Henry St area in Sovereign for the purposes of dock placement and Lake Dr issues. Sgt Patchin of our Department assisted in the dock placement to assure that proper placement occurred at those road ends.

11) I attended the 2nd quarter CERT training to familiarize CERT members with the fully equipped trailer that we now have available for the team.

12) In support of ACT NOW and the GTPD missions, I attended the Bowling Tournament at Fred's Restaurant and Bowling Alley and sold tickets on behalf of our group.

13) I attended the Michigan Association of Chiefs of Police Legislative meeting in my board member role via conference call this past month. Many pieces of legislation were reviewed to obtain positions on the bills to convey to our lawmakers in Lansing, Mi.

14) This past month, I have spent an ample amount of time reviewing and changing/updating all job descriptions in the Department as same had not been updated for many years. The position descriptions need to accurately depict tasks and assignments that are actually being done per position.

15) In line with the job descriptions, in order to make the Department more efficient and provide for better hours available at the office to the public on weekends regularly and to provide some supervision being available in the afternoon and evening hours, I am proposing some command changes which I have discussed with the board at a recent work session.

16) This month continues my coordination work with the insurance company from our recent totaled patrol car as a result of a car/deer crash that took place. We are operating one car down at this time.

17) I hosted a traffic safety meeting in preparation for the upcoming Higgins Lake Sunrise Run which will take place on June 17, 2017.

18) I continue to supervise the technology upgrades in our building regarding the Security and Interview Room camera system as well as an associated security system. Additionally, we have replaced a workstation per our technology goals as it was aging and showing signs of failure.

19) The Department attended the Roscommon/Higgins Lk Chamber of Commerce Business Expo with ACT-NOW and members from the CERT Team in hopes of recruiting more civilians to our efforts. The Expo was well attended and we did receive some prospects from the event to join our CERT Team.

20) I met with Sheriff Stern and South Higgins Lake State Park Manager Roberts for the purposes of discussing the Fourth of July activity at the Park and a needs assessment for an enforcement effort at the Park again this year. In reviewing our statistics from last year to include park usage and events experienced last year, it was determined that an enforcement effort would be needed again this year and should occur on Saturday July 1, 2017 and Sunday July 2, 2017. Primary hours of presence will be from 1300 hrs to 2100 hrs each day. Specific and operations plan to follow.

21) I attended the Roscommon County Law Enforcement Command meeting held at Fred's Restaurant this month to discuss various issues in common and upcoming enforcement events for the summer that would need coordination.

22) I met with Attorney Hess at his office for the purposes of discussing current open Ordinance case files and their need for Circuit Court action as well as to discuss the proposed Commercial Noise and Amplified Sound Police powered Ordinance.

23) I attended the Friends For Safe Schools meeting where our work continues for community funding of "The Boot" project.

24) I met an additional time with Sgt Patchin and Administrative Clerk Julie Hill to put together all proposed job description changes(referred to above) and get them into a workable order to present to the Board at the June Work session.

25) I hosted meeting of all partners for the July 1 and 2, 2017 Enforcement effort at the South Higgins Lk State Park where I presented my First draft Operations Plan to the group. We went over same to fill in assets and fine tune the Plan.

26) I attended the Department Spring/Summer Range day at Kirtland Community College where all Department members qualified with all Department weapons. All members qualified as required.

Highlights this month for the Department include;

We had a very busy Memorial Day weekend overall and the staff here handled things very well.

As a reminder again, there will not be a June ACT NOW community meeting in lieu of ACT NOW's participation in the June 17, 2017 Higgins Lake Sunrise Run.
