### ***Gerrish Township Police Monthly Report 07-01-17 through 07-31-17***

The Gerrish Township Police Department responded to a total of 196 calls for service for the month of July 2017.

The Department reports 44 total citations recording 19 traffic violations, 27 Misdemeanor violations, 10 written verbal warnings and 1 Felony citation. (See attached report for breakdown).

The Department also reports 19 custodial arrests for the monthly period. (See attached report for breakdown).

#### **Training:**

The Department reports no hours of training this month as the Department was short staffed for most of the month with an Officer on Family Medical Leave. (See attached breakdown)

Chief Hill highlighted activity for the reported month is as follows:

- 1) I provided Incident Command and authored the operational plan for the 2017 South Higgins Lk State Park Youth Alcohol Enforcement effort which took place on July 1 and 2, 2017 from 1300 hrs to 2100 hrs.
- 2) I attended the Gerrish Township Board monthly work session to brief same on our Department activities this past month.
- 3) I attended a Gerrish Township Property Maintenance Committee meeting where we agreed to visit Garfield Township in Grand Traverse County to seek best practices information.
- 4) As a note, I was gone on vacation for a 10 day period in July 2017.
- 5) I prepared the June Monthly Board Reports as required.
- 6) I attended the LEPT planning meeting this month.
- 7) I attended the FFSS meeting to discuss and plan further fundraising to pay for "The Boot" program that installed all safety devices at our area schools.
- 8) I attended the AVI planning team meeting to further prepare for a full scale training exercise at the Roscommon County Courthouse.
- 9) I presided over one Staff meeting this month.

John received a congratulatory plaque for his outstanding committed service to this Community.
