## ***Gerrish Township Police Monthly Report 11-01-17 through 11-30-17***

The Gerrish Township Police Department responded to a total of 87 calls for service for the month of November 2017.

The Department reports 18 total citations listing 18 traffic violations, 8 written verbal warnings, and 3 misdemeanor citations. 1 Felony pending citation. (See attached for breakdown).

The Department reports 4 custodial arrests for the month. (See attached arrest report).

### **Training:**

A total of 41 contact hours of training are reported for this month. An additional 36.9 Credit hours were achieved through Learn.com, our online Policy training location. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the Township Board monthly work session as required.
- 2) I attended the ACT NOW Executive Board meeting in my advisory role.
- 3) I met with the Salvation Army Representative at their request regarding the possibility of our Department ringing the bell at the Family Fare on 12-15-17 on behalf of their organization.
- 4) I attended the regular Gerrish Township monthly board meeting.
- 5) I organized and facilitated Oral Board interviews and candidate presentations for the new afternoon Road Patrol Sergeant that began 11-18-17.
- 6) I attended the Michigan Association of Chiefs of Police Strategic planning sessions to plot the course of the organization for the next couple of years. I attended in my roles as a Past President, District 9 Representative/Executive Board and Legislative board member role.
- 7) I met with a committee of ACT-NOW Board members for the purposes of the development of a usable power point presentation for traveling to certain organizations to solicit more active ACT-NOW members.
- 8) I attended the Roscommon County Law Enforcement Administrator's meeting held at Fred's Restaurant in Roscommon.
- 9) I created, attended and presented a power point presentation for the Medical Marijuana Public Hearing at the Gerrish Township Board request. The presentation was a prelude to the hearing for framing the discussion.

10) I organized the CERT 4<sup>th</sup> quarter training at the Gerrish Township Hall in my Advisory role to the CERT group. This training was based on policy and procedure and annual bag checks. Lt Patchin presented to the group in my absence as the time conflicted with another duty that required my attention.

11) I attended the ACT-NOW Donor Appreciation Dinner held at Fred's Restaurant.

12) I attended the ACT-NOW, Gerrish Township Police bowling fundraiser to assist with funding the Roscommon Area Public School graduating senior scholarships presented each year to 2 RAPS students.

13) I continue my work with the Friends for Safe Schools fund in the RCCF to provide payment for "The Boot" project that has been initiated to further harden our schools against active shooter activity. This past month, I participated with the "No Shave" November campaign to benefit the project.

14) I have worked on many other Administrative issues throughout the month which were included in my Department Update report to the board at the Monthly board work session.

15) I attended the Local Emergency Planning Team meeting held at the Roscommon County Commissioner's meeting room.

16) I chaired the Kids Helping Kids for Christmas meeting to provide a Christmas evening of dinner, Santa visit and gifts for foster children in Roscommon County and their families.

17) I attended an all Roscommon High School assembly with other Roscommon County Law Enforcement Administrators to present a technology and the law seminar. The focus was technology and how the law works surrounding devices that kids own and the dangers of violating laws without having knowledge of the laws that govern. Social media platforms and their associated data that they post were accentuated.

18) I attended a Michigan Critical Incident Management System (MiCims) training to be able to function as a Law Enforcement representative at the Roscommon Emergency Management Operations Center at the time of need.

19) I attended the Roscommon County Community Correction Authority Board meeting in my board member capacity to discuss social programs for jail inmates to prepare them for their release back into society.

In other news for upcoming events to note;

On December 3, 2017 at 5:00 p.m., I helped supervise the wrapping of the Kids Helping Kids Christmas gifts. The gifts are wrapped by many students from different organizations throughout the County as we prepare for the Saturday Dec. 9, 2017 Foster kids Christmas 2017.
