Gerrish Township Police Monthly Report 12-01-17 through 12-31-17

The Gerrish Township Police Department responded to a total of 127 calls for service for the month December 2017.

The Department reports 12 total citations listing 10 traffic violations, 6 written verbal warnings, and 4 misdemeanor charge statistics for the month. (See attached for breakdown)

The Department reports 5 custodial arrests for the month. (See attached arrest report)

Training:

A total of 14 contact hours of training and 10.25 Credit hrs. Online training through Learncom thus completing the required policy review for 2017 are reported for this month. (See attached detail document)

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the Gerrish Township monthly work session as required and gave an update on police activities.
- 2) I attended the ACT NOW Executive Board meeting in my Advisory role.
- 3) I coordinated and conducted interviews for the vetting of 2017 Shop with a Cop families to include all special needs as they related to gas cards, food cards and heating issues for two families.
- 4) I organized and attended the Kids Helping Kids wrapping gathering for the purposes of wrapping all gifts related to the foster children of the County.
- 5) I helped coordinate, attended and emceed the 2017 Kids Helping Kids at Christmas program as we provided gifts and an evening of Christmas with Santa visit for 34 foster kids and dinner for 10 foster families.
- 6) The Gerrish Township Police hosted the 2017 Christmas party wrapping session for Shop with a Cop.
- 7) I attended the regular Gerrish Township Board meeting as required.
- 8) I attended the Gerrish Township Fire Department/Gerrish Township Christmas Party held at the Streamside Restaurant.
- 9) I attended the monthly Northern Michigan Children's Assessment Center team meeting to discuss current cases.

- 10) The Department and ACT-NOW served 7 full families to 36 individuals for the 2017 Shop with a Cop Program. We also provided a new propane tank and complete fill for a resident in the Township. Also, we provided money for a furnace repair for another family. We provided an additional \$400.00 in gas cards for two of the families and \$300.00 in a Family Fare Card for another.
- 11) The Department and ACT-NOW additionally provided funds for a bike and associated safety equipment for a young man living in Township whose primary mode of transportation is a bike year around.
- 12) I attended the monthly LEPT meeting as a Local Law Enforcement representative.
- 13) The Department delivered all Shop with a Cop gifts on December 20, 2017 without incident.
- 14) I conducted one staff meeting this month. The second was not achieved due to vacations and time off request accommodations for the Officers.
- 15) I attended a Property Maintenance Committee meeting held at the Gerrish Township Hall and after same I was given the task of making an Ordinance document ready for a meeting for initial review and get answers to several questions regarding the Ordinance adoption to adhere to the International Property Maintenance Code. We discussed rental units, various sections and definitions.
- 16) I gave an Emergency Preparedness presentation at the Good Shepherd United Methodist Church of the North at their request. Additionally, Lt Brandon Rodgers came for the FIRE/EMS service to discuss medical equipment that the Church has and the use of same. He also demonstrated the proper use of a Fire extinguisher and the different types available for use at the Church. In the spring of 2018, I will begin working with them and their Executive board on establishing a proper written plan and during that process we will go over locations of safety, making some of the current areas of concern into a harder target.
- 17) I attended the Roscommon County Law Enforcement Administrator's Meeting and lunch at Fred's Restaurant in Roscommon.
- 18) Our Department, CERT and Fire/EMS and myself rang the bell for the Salvation Army on Dec.15, 2017 from 0900 hrs. through 2000 hrs. raising money during the Holiday Season. We raised \$730.00 per the coordinator.
- 19) I attended the Michigan Association of Chiefs of Police Executive Board and Legislative meetings in my board member capacity via conference call this month.

I wish to send out a big thank you from our Department to ACT-NOW for their fundraising efforts as well as our wonderful Community for their donations to make 2017 a success for those in need at Christmas.
