Gerrish Township Police Monthly Report 02-01-18 through 02-28-18

The Gerrish Township Police Department responded to a total of 97 calls for service for the short month of February 2018.

The Department reports 6 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 24 total citations listing 25 traffic violations, 4 Misdemeanor violations and 6 verbal warnings issued for the month. (See attached for breakdown).

Training:

A total of 52 Contact hours of training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) Lt Patchin and I attended the Michigan Association of Police Chiefs mid-winter conference and took various training classes to include a training presentations from Lt. Brian Murphy that was shot 15 times and survived in the Wisconsin Sikh Temple shooting. Training included their response and after action information, 911 tapes and his survival mentality that got him through after being shot numerous times at point blank range.
- 2) I attended the Gerrish Township Board work session as required and updated the board on Department activities.
- 3) I attended the ACT-NOW Executive Board meeting in my advisory board member capacity to plan activities to benefit our community in 2018. Our planning session included our goals and objectives for 2018.
- 4) I attended the ACT-NOW/GTPD Bowling Tournament and fundraiser held at Fred's Restaurant and Bowling Center in Roscommon where we raised \$1771.00 for projects supported by our organizations. \$1100.00 in prize money was awarded to the top three winners. We also held a live auction, strike ball and 50/50 raffle at the fundraising tournament.
- 5) I coordinated with CERT for renewal of CERT members CPR/AED cards and training.

- 6) I hosted and attended a department staff meeting for the purpose of presenting the Township's new proposed BCN HMO Health Insurance change that will occur on May 1, 2018.
- 7) I chaired the 911 Technical Board meeting this month as we went over Policy proposed changes to the Law Enforcement related policies for 2018.
- 8) The Department received an audit from MSP LEIN Field Services regarding the handling of our Criminal Justice Information. This audit occurs once every three years. I am awaiting the final result but from our Auditor visit verbally, she advised that we keep exceptional accurate records. We discussed our future need to get off of a shared server with the Township as the new Federal Mandate requires that Criminal Justice Information be on a stand-alone server. I advised her that we should have one up and running by March 31, 2018. Additionally, some of our applications needed a warning statement placed on login screens. I look forward to having this rectified by March 31, 2018.
- 9) I assisted with a Drug dog sweep of the Roscommon High School as requested by the Roscommon Area Public Schools.
- 10) I attended the Roscommon County Law Enforcement Administrators lunch meeting held at Fred's Restaurant in Roscommon, MI.
- 11) I attended Lockdown Drills at all three Roscommon Area Public Schools this month. Lockdown drills are associated with pre-planning prior to a potential active shooter situation.
- 12) I attended a web demonstration of a software product we saw at the Chiefs Conference at the Police Department with Lt Brandon Rodgers and Clerk Kathleen Patchin. The software allows for a record management system to train on policy, track memos and an early warning system of management of employees. I intend to order the product even if the other parts of the Township find that they would not use. The product will replace Learncom and is less expensive than same and allows for a more robust user defined area when using our policies for training each year and the documentation of same.
- 13) I attended a Property Maintenance Committee meeting to look over a proposed Ordinance to adopt the International Property Maintenance Code by reference and to amend same to reflect the rental regulations that would fit Gerrish Township.
