Gerrish Township Police Monthly Report 03-01-18 through 03-31-18

The Gerrish Township Police Department responded to a total of 90 calls for service for the month of March 2018.

The Department reports 12 various custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 29 total citations listing 32 traffic violations, 8 misdemeanor cited violations, 12 verbal warnings for the month. (See attached for breakdown).

Training:

The Department reports no dedicated hours of continuing education this month. (See attached document).

Chief Hill highlighted activity for the reported month as follows:

- 1) I attended the Gerrish Township Annual, Regular, and General Budget meetings.
- 2) I attended one Gerrish Township Board work session/Department Head meeting.
- 3) I participated in the Gerrish Township Fire/EMS Family night held this past month.
- 4) I attended the ACT NOW Monthly Executive Board meeting this month.
- 5) I met with the Armed Forces Benefit Assn Representative to hear their proposals for making Armed Services benefits available to our First Responders. We discussed the details and I scheduled him to present to my Officers at a staff meeting.
- 6) I conducted one staff meeting this month and much of same was dedicated to discussing Health Benefit proposed changes, Life Insurance available for purchase by First Responders through the Armed Forces Benefit Assn and other case review as normal for the meetings.
- 7) I chaired one 911 Technical Board meeting in my chairperson role. The meeting was dedicated to the yearly review of Policy and Procedure for the center.
- 8) I organized and chaired two planning sessions this month for the upcoming quarterly training. The CERT principle players were in attendance to plan for a large training exercise on May 5, 2018 in Gerrish Township.
- 9) I attended a Friends for Safe School Committee meeting to discuss the need for a closure of all invoices and final work to be performed at the contracted schools to assist in getting the group refocused for future plans and needs. From that meeting, a date was given of 3-19-18 at 1000 hrs to meet with and walk through each building with the owner of the Lockdown Company to get the schools and the company on the same page of the work done, needed to be done, and a total count

for payment if payment is due. This was accomplished at the Roscommon Area Public Schools in Gerrish Township.

10) I also received our "training" boot installed in our office with supplemental keys provided for each patrol unit and office key on 3-20-18.

11) I attended the MACP Legislative Board meeting via conference call to assess the positions of the MACP on current proposed legislation that affects Law Enforcement.

12) I attended the MACP Executive Board meeting via conference call in my District 9 Executive Board representative role and as a Past President.

13) I attended the monthly Northern Michigan Children's Assessment Center team meeting to discuss all current cases being worked out of the Center.

14) I attended the Roscommon County Law Enforcement Administrators meeting held this month. While there, we discussed the current rash of threats to schools in general and the specific threats to schools in our Township and County. It was discussed with the Prosecutor about a letter that needed to be sent to schools and the public to explain our posture on all threats and that same will be treated as very serious. We also agreed on a method of operation and investigation on these cases so all cases are handled in the same consistent manner.

15) This past month, we began our work on remodeling our SOP manual into various chapters to coincide with the new Michigan Association of Chiefs of Police accreditation model. I still intend on seeking State Accreditation in the coming 2 years. This is a beginning step and will require a substantive amount of time to accomplish.

16) I attended a LEPC meeting to hear what Emergency Management plans are coming for our County in the future. Currently CodeRed has just been purchased and rolled out as a mass notification system at times of emergencies. This system does have an App available for free for iPhones and Android systems. As soon as the details are worked out, a media campaign will follow to educate the general public for sign up.

17) I attended a Property Maintenance Committee meeting to further the process of adopting the International Property Maintenance Code by Ordinance and thus beginning the process of addressing long term rental properties in a state of disrepair and devaluing neighboring property owners, as well as causing health and safety concerns.

18) This past month, I oversaw the installation and implementation of a new server system that separates our Police Department from the Township server that is receiving a new server this month to accommodate their needs. Both servers were very antiquated and no longer reliable nor large enough to handle all Township Service needs.

19) We have notified our MSP LEIN Auditor of our server separation and forwarded an appropriate server diagram as required. Currently we are in a technology audit process to comply with all Federal/State cyberspace mandates to protect our Criminal Justice Information systems. I am looking forward to our final audit findings and will forward to the board when that occurs.

Other Department notes for update;

In other Department business;

- I have begun trying to find grants available, public or private to assist us in upgrading six (6) 800 MHZ portables for our Department. The Total project will cost \$26,970.00. Four (4) of our current radios are of 2003 vintage and two (2) are from 2007. I have 1 radio that I won at the Chief Summer conference 2 years ago that is up to date. They are scheduled to end support via our vendor. I have enlisted a free grant location help through Motorola at this


time. I have filled out the pre-screening document to qualify for help. If a grant can be located to match us, a fee will need to be paid for the service and assistance.

- Fiscally, I wanted to advise that as our 2017-2018 budget closed on 3-31-18. I can happily report that I exceeded my expectations regarding fund balance that I predicted 18 months ago during that budget planning cycle. This has been a difficult year with many unexpected or out of cycle budget expenditures had to occur. I will continue to look for grant opportunities or other funding opportunities to keep my budget solvent and in good shape each year.
