## Gerrish Township Police Monthly Report Abbreviated Monthly Report 04-01-18 through 04-27-18

The Gerrish Township Police Department responded to a total of 59 calls for service for the shortened month of April 1, 2018 through April 27, 2018 month April 2018. (See attached report for breakdown).

The Department reports 11 custodial arrest statistics for the above reporting period. (See attached report for breakdown).

The Department reports 11 total citations listing 11 traffic violations, 4 misdemeanor violations, and 4 written verbal warnings for the month. (See attached for breakdown).

#### Training:

21 continuing education contact training hours are reported for the above reporting period this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the regular Township board work session as required and presented many topics for review by the board.
- 2) I attended the MACP Legislative Board meeting in my capacity as a representative of Northern Lower Michigan, via teleconference.
- 3) I attended the ACT-NOW Executive Board meeting in my Advisory Board member capacity where we reviewed scholarship applications for consideration for the two \$1000.00 each scholarships presented to two graduating Roscommon Area Public Schools students. Two students were selected and their names forwarded to the High School Award Nights coordinators.
- 4) I attended the Child Death Review Team Meeting to discuss the child death circumstances and examine educational concepts to address prevention needs in the County.
- 5) I attended the Gerrish Township Regular Board meeting as required.
- 6) I attended the monthly Roscommon County Law Enforcement Administrator's meeting held at Fred's Restaurant in Roscommon, Mi.
- 7) The Department turned over 38.8 lbs. of unwanted prescription pills to the Tip of the Mitt Watershed council at the Petoskey Department of Public Safety for proper disposal.

- 8) I attended an online webinar with Caliber Press, our records management vendors for the purposes of going over the new updated version of our software.
- 9) This past month I made arrangements with 24x7 Sewer and Drain to empty and maintenance our Police Department garage drain system.
- 10) I have chaired two CERT Training planning sessions to plan for and execute a training exercise on May 19, 2018 from 10:00 am to 3:00 p.m. We will be having in a fun run/poker style where there will be training opportunities at several sites that correspond with their basic training manuals in order to practice their skills in a variety of different ways.
- 11) This past month, I arranged for and oversaw the MACP District 9 election for the Executive board seat for the 12 Counties that make up District 9 for the MACP. Congratulations to Chief Georgia Andres from Newaygo City PD for her election to the seat. Also, congratulations to Chief John Beam of Evart PD for being elected as the alternate.
- 12) This past month I hosted a training for the South Higgins Lake State Park Commissioned Officers to go over new law changes that will affect them this summer in their handling of enforcement issues. Topic included Domestic Violence complaint handling, OWI drugs or alcohol enforcement, Minors in Possession of Alcohol or Tobacco etc.
- 13) I attended a Friends for Safe Schools meeting, we confirmed that the Roscommon Area Pubic Schools has all work completed and are now able to release the remainder of the funds to the Lockdown Company. Work continues on the promised plaques for the individual buildings to recognize donors to the project. The school is to select the style of plaques for us to put out to vendors for pricing. The committee cannot use the donated funds to the project for the plaques so the group has sought some angel funders for the plaques.
- 14) This month, I can announce that the ACT-NOW Scrap Metal project is up and running again this spring and the trailer next to the Impound lot is re-opened and residents can drop off their scrap metal for processing.
- 15) At our staff meeting this month, I had On Duty Gear, our bullet proof vendor come and measure all officers for new vests as our current vests will have met their 5 year product liability life span. I have also applied for the BVP grant assistance from the Justice Department which will pay one half of the cost of the approved NIJ vests. This is a re-imbursement grant. We will pay up front and submit receipts and get repaid later in the year.
- 16) I attended the Sexual Assault Response Team (SART) policy and protocol meeting to develop their documents to deploy the Sexual Assault Nurse Examiner (SANE) program granted out of the Office of Violence against Women. The grant is a 3 year grant to establish and become operational to coordinate with area agencies and hospitals.
- 17) Our State of Michigan LEIN Audit of our Department records by the MSP was done on 2-14-18, we are now in a Technology audit due to concerns in our IT security encryption of data area. At the end of last week, our IT completed all our bulleted items from MSP Technology with the final approval of our Network Map.
- As I notified the Township Board last month, I knew this was coming as the server project was delayed from January 2018 due to delivery time and installation woes. Same was put off until the separate server came in and was installed just before 3-31-18. This date was after the 2-14-18 audit day and caused the subsequent notification of non-compliancy and veiled threats of sanctions if not corrected. I have 45 days to respond with an "Action Plan" from the letter dated 4-3-18, despite the fact it was received and had been installed so that we were isolated from the General Township. I have created the action plan and same was sent back on 4-19-18 via email and hard copy US Mail. As a note, majority of the items were scheduled to be fixed upon the installation of the separate Police Department server and were corrected by 3-31-18. I have it well in hand at this point and I have a self-imposed department deadline of May 10, 2018 for my vendors, our IT and our

LASO/TAC officers. This will assure that it is not in my office as we begin our summer season. I am not happy with the process that the State used regarding this issue.

A look ahead;

Gerrish Township Police and ACT-NOW will be doing our spring road cleanup on May 8, 2018 beginning at 4:00 p.m. All who want to assist are invited with pizza and pop to follow.

GTPD, ACT-NOW and CERT will be at the Higgins Lake-Roscommon Business Expo on 5-16-18 from 3:00 p.m.-6:00 p.m.
