### ***Gerrish Township Police Monthly Report 07-01-18 through 07-31-18***

The Gerrish Township Police Department responded to a total of 221 calls for service for the month of July 2018.

The Department reports 20 total citations recording 17 traffic violations, 9 Misdemeanor violations, 5 written verbal warnings, 1 Felony citation, 1 Ordinance Violation and 3 Minor In Possession Civil Infractions. (See attached report for breakdown).

The Department also reports 9 custodial arrests for the monthly period. (See attached report for breakdown).

#### **Training:**

The Department reports 14 hours of training this month. (See attached breakdown)

Chief Hill highlighted activity for the reported month is as follows:

- 1) I authored the Police Department's Monthly work session update that was delivered in my absence by Lt Patchin.
- 2) I attended the ACT-NOW Executive Board meeting in my Advisory member capacity.
- 3) I chaired a 911 Technical Board meeting in my role as the Chairperson of the committee which reviews 911 Policies and procedures.
- 4) I prepared the July Monthly Board Reports as required for the July Regular Township Board meeting.
- 5) I attended the July Regular Gerrish Township Board meeting
- 6) I attended the Northern Michigan Children's Assessment Center Case Review Team meeting.
- 7) Lt Patchin and I attended the Grand Opening of the Lions Den faith based addiction recovery center in the Village of Roscommon. The center will be a great resource for addiction treatment as it is a Non-Profit, no fee place for people that are addicted to work their way out of their situation.
- 8) I attended the AVI planning meeting for the exercise planned for the Our Lady of the Lakes, Prudenville full scale exercise.
- 9) I attended the Annual ACT-NOW Community meeting/Election of Officers and emceed the election process to install new members to the board and honoring our outgoing 11 year Chair, Mary Link.

- 10) I attended the LEPT planning meeting this month held at the Roscommon County Commissioner's Room.
- 11) I held two staff meetings this month, one to provide classroom course of learning module for our required Firearms mandate per MCOLES. We additionally reviewed the Department Firearms policy. The second meeting, we reviewed all open case files as a team so that all are aware of current open complaints in the Department.
- 12) I attended the Roscommon County Law Enforcement Administrators Meeting lunch held at Fred's Restaurant in Roscommon, Mi.
- 13) This past month, I met with Road Commission Manager O'Rourke over issues at the Reaves Forest/Bradish Ave/Lake Drive intersection and the activities that are occurring regarding tree removal in road right of way.
- 14) Lt Patchin and I attended a LEIN Field Services webinar to learn about yet another change to the access of a program that was housed in LEIN which is no longer housed in same. We are reviewing our options as they relate to the additional costs being proposed by the State of Michigan. The program is an integral part of our work responsibilities as they relate to our open warrants in file and in LEIN for pick up. This is still a work in progress.
- 15) I have met with the Prosecutor individually to discuss the prevalent youth "Sexting" issue in our Community as we are currently working an open file that shows the pervasive issue. We met to discuss strategies and charging involved in these cases.

In other news;

This summer continues to be very busy with many visitors and people using their cabins more so than in the past summers. We believe this to be a sign of great weather and a better economy being felt in the area. With that being considered, our activities and disputes at the parallel paper roads has increased. Additionally, we have seen a rise in "people crimes" and an actual slight decrease in "property crimes."

We are happy to announce that John Ellis was voted as the new Chairperson for the ACT-NOW Executive Board for the 2018-2019. John has a great energy about him with a selfless attitude. I look forward to his leadership. Additionally, John is an active CERT team member who is always there when we call. We applaud and thank John for stepping up to this role.

We also saw the retirement of Mary Link from the ACT-NOW Executive Board Chairperson role after 11 years of service in that capacity. The group honored her with a service plaque noting her personal mantra of all things being about "Others." We sincerely thank Mary and she has assured us that she would still be active in come events, just not in that leadership role.
