Gerrish Township Police Monthly Report 08-01-18 through 08-31-18

The Gerrish Township Police Department responded to a total of 146 calls for service for the month of August 2018.

The Department reports 11 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 21 total citations listing 15 traffic violations, 10 misdemeanor charges, 5 verbal traffic warnings, 1 Anti-Noise Ordinance violation and 1 Felony (See attached for breakdown).

Training:

A total of 58 hours of training are reported for this month. (See attached detail document).

- 7) I attended the Northern Michigan Children's Assessment Center team meeting as a member of the team that meets monthly to go over Children's Sexual Assault and neglect Abuse cases being handled by the Center.
- 8) I attended the ACT-NOW/GTPD Golf outing fundraiser that took place on 8-11-18.
- 9) Lt Patchin and I attended a Lessons Learned training regarding the Legalization of Marijuana based upon the studies from Colorado, Oregon and Washington State. We heard statistical data regarding the unintended consequences being experienced in these states.
