### ***Gerrish Township Police Monthly Report 09-01-18 through 09-30-18***

The Gerrish Township Police Department responded to a total of 120 calls for service for the month of September 2018.

The Department reports 6 various Misdemeanor custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 27 total citations listing 24 traffic violations, 9 misdemeanor violations, 9 written verbal warnings. (See attached for breakdown).

#### **Training:**

A total of 16 hours of training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the ACT-NOW Executive Board meeting in my advisory capacity.
- 2) Our Department held the ACT-NOW/GTPD annual road cleanup. We clean the area on both sides of the road on Co Rd 100 from Pioneer Hill to Hillsdale Dr twice a year.
- 3) I attended the Gerrish Township Board work session as required and gave a Department update on Police Department activities.
- 4) I attended the NMCAC team meeting to discuss the Center's cases in Roscommon County and their current status.
- 5) I held one staff meeting this month to go over all open case files for discussion.
- 6) I attended the regular Gerrish Township Board meeting as required.
- 7) I attended the Property Maintenance meeting to go over final documents and Ordinance verbiage.
- 8) I visited several roads in the Township to show our Township Treasurer the current issues before the Police Department this past summer.
- 9) I met with some citizens regarding Lilly Lane and Donn M Blvd issues from this past summer.
- 10) I attended the Child Death Review Team meeting to go over and discuss the Child Death Investigation in the County to see what suggestions, education or programs that could reduce our infant deaths as they relate to sleeping and suffocation deaths.
- 11) I chaired the 911 Technical Board meeting in my Chairperson role to review policies and procedures deployed by our Center.

- 12) I attended and provided Incident Command for the 2017 Law Enforcement Torch Run which took place without incident.
- 13) I attended the Michigan Association of Chiefs of Police Legislative Committee meeting in my member capacity to review Legislative bills that affect the Law Enforcement and Government positions. I did this via telephone conference.
- 14) I assisted with the set-up of the booth area at the Michigan Firemen's Memorial grounds in preparation for the Shop with a Cop fundraiser for ACT-NOW and GTPD. I stayed while sales occurred for most of the day.
- 15) I attended the Roscommon County Law Enforcement Administrators lunch meeting held at Fred's Restaurant in Roscommon, Mi.
- 16) I attended the Friends for Safe School meeting to further our collaborative work effort regarding "The Boot" program. We will begin work on financing of the recognition plaques as "The Boot" product is installed in the Roscommon County Schools as targeted by the group. Additionally, we will begin work to further the safety of the schools in collaborating with same for further educational safety endeavors.
- 17) A traffic Safety meeting was held to prepare for our Township collaborative Trunk or Treat 2018 event to be held on October 31, 2018 here at the Township complex.
- 18) I met with Attorney Hess regarding the final review of the draft long term Rental Ordinance and language to adopt by reference the International Property Maintenance Code. I await his final review to meet with the Township Board for further discussion and eventually a public hearing discussion. This work is conducted in connection with the Property Maintenance Committee work from the past year and several meetings.
- 19) This past month, I have accepted the temporary chairperson role for Grayson's Gift to further the work of the group of reaching our hearing impaired community by supplying free smoke detectors, beds shaker alarms and strobe light attachment. Their board had a loss of members due to some of the principal players moving away from the community. I will serve in the role until May 2018. We will be installing many of these in the first week of October 2018 in a partnership with the Gerrish Township Fire/EMS and the Grayson's Gift non-profit organization.

In other news;

Per Sheriff's request, we assisted the Roscommon County Sheriff Dept. at the 2018 Michigan Firemen's Memorial parade. Additionally, the Department assisted ACT-NOW with their annual fundraiser of selling ACT-NOW Shop with a Cop stuffed animals at the Fairgrounds. This year the selected stuffed animal was a dinosaur theme. They were once again provided by Bob Edwards of our Community. The support was incredible. I would like to thank Officer Shannon Fick of the Police Department for serving with me and other ACT-NOW members on the sales day on our behalf at the Fairgrounds this year.

The Department participated in an initiative to support the Special Olympics entitled "Law Enforcement Torch Run." We raised \$1150.00. The event was organized by Officer Shannon Fick and was done in conjunction with the National Event. All money was raised for Special Olympics of Michigan.

A look ahead;

- The walk to school planned for October 10, 2018 has been cancelled due to Road Construction in the village near the VFW Hall where the event usually originates.
- On October 26, 2018 from 8:00 a.m. to 9:30 a.m. we will hold our first Gerrish Township Police Department "Coffee with a Cop." Please join us at the Bird and the Bear at Co Rd 100 and Co Rd 103 location where the Gerrish Township Police Officer Association would like to offer a cup of coffee on your Officers. We hope to have just a great meet and greet and free conversation with our public.
- Wednesday, October 31, 2018, we will host the 10th Annual Trunk or Treat at the Gerrish Township Municipal complex. The Trunk or Treat will be from 6:00 p.m. to 7:30 p.m. with Trunks being requested to be set up beginning at 4:15 p.m. For the people that bring a vehicle and participate in the Trunk decoration for Trunk or Treat there will be prizes for the Best Decorated Trunk, Most Creative Trunk and Scariest Trunk. There will be 8 random participation drawings this year as well for the trunk participants. Warm Cider and donuts and warming stations will be provided. The event is being organized by a committee led by Officer Eric Muszynski and Gerrish Township Treasurer Leasa Tulgetske. Please help us by bringing your cars down, decorate your trunks and cars and provide candy for the trick or treaters. Last years event had over 1000 people that participated. It is a great, safe night out!
