### *Gerrish Township Police Monthly Report 10-01-18 through 10-31-18*

The Gerrish Township Police Department responded to a total of 106 calls for service for the month of October 2018.

The Department reports 7 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 19 citations listing 17 traffic violations, 6 misdemeanor citations and 5 verbal warnings for the month. (See attached for breakdown).

#### Training:

A total of 56 contact hours of training are reported for the month of October 2018. (See attached detail document).

Chief Hill highlighted activity for the month reported as follows:

- 1) I attended the ACT-NOW Executive Board meeting in my advisory role.
- 2) I met with Road Commission Manager Tim O'Rourke regarding Reeves Forest, Henry, Carlos Avenue and Lake Drive.
- 3) This month the whole Department was offered an occupational flu shot as in past years. All but two employees opted in for the shot.
- 4) This month, the Department partnered with Grayson's Gift and the GTFD/EMS in identifying and installing bed shaker mechanisms, smoke alarms and smoke detectors in residences of identified need. A Total of 17 units have been installed to date.
- 5) I attended the regular scheduled Gerrish Township Board work session.
- 6) I coordinated a safety planning meeting for the 2018 "Walk to School Day" for the Roscommon Area Public Schools which was ultimately cancelled due to construction in the Village of Roscommon near the VFW Post where the kids were scheduled to be dropped off at.
- 7) I attended an Officer Involved Shooting Training course this month to identify best practices for policy and procedure after an involved shooting occurs.
- 8) I arranged for a seminar to be held at the Roscommon High School to address the growing problem of "Sexting" in our schools for both the High School students and Middle School students. I did this in partnership with Prosecutor Beebe and other Law Enforcement Administrators to create an awareness to students about the consequences of the behavior, which we have seen a rise in recently. The seminar was held on 10-31-18 and addressed the 6<sup>th</sup> through 8<sup>th</sup> grades and a

separate session for the 9<sup>th</sup> through 12<sup>th</sup> grade. The presentation was presented by Lt. Lator of the MSP Houghton Lake Post who specializes in this type of training.

9) I attended the Roscommon County Child Death Review team meeting in my board member capacity. Many strategies were discussed to assist in reducing the recent higher number of Child deaths in our County. Specifically, we discussed and brought to the County a Child Death investigation class and awareness training available to Police, Fire, EMS and other social providers.

10) I assisted with making arrangements for a local alcoholic individual that we arrested this past month to be enrolled in the Lion's Den for assessment and ultimately he was placed in a Lion's Den facility in Ohio.

11) I attended the Northern Michigan Chiefs of Police meeting this past month held at Audie's Restaurant in Mackinaw City. Many legislative issue were discussed as well as issues facing Northern Michigan Communities.

12) The Department participated in Lockdown Drills at all three schools on the Roscommon Area Public Schools Campus.

13) I attended, trained and qualified with our Department firearms as required as well as our Taser recertification. This shoot was a low light/dark environment qualification held at the KCC shooting range.

14) I attended the monthly NMCAC team review at the NMCAC in Roscommon reviewing CSC/Child Abuse and neglect cases.

15) I attended the LEPT meeting held at the Commissioners Room at the County Building.

16) The Department CPR/AED Instructor Julie Hill conducted two classes and trained 15 people from two churches. One class was held at St Hubert's and the other at St James.

17) I attended the Roscommon County Law Enforcement Administrators meeting and lunch at Fred's Restaurant in Roscommon.

18) I hosted and attended one Trunk or Treat 2018 event planning meeting.

19) I hosted and chaired a safety meeting regarding the 2018 Trunk or Treat event to discuss traffic flow and traffic assignments for the safety of the event.

20) I chaired and attended a Grayson's Gift board meeting for the purposes of continuing the flow of bed shaker, smoke alarms and carbon monoxide installations. Additionally we are preparing for a presentation at the Houghton Lake Senior citizen lunch on Nov 14, 2018 in hopes of gaining more installations to the hard of hearing community.

21) Lt Patchin and I attended a Friends for Safe School committee meeting this month as we move towards the close of the Boot project with the purchasing and installation of plaques for each building.

22) I chaired a Kids Helping Kids meeting at the GTPD to plan for the 2018 10<sup>th</sup> Annual event for Foster Children at Christmas. This was an organizational meeting to accomplish this year's tasks in preparing for the event scheduled Dec. 8, 2018 graciously held at the Good Shepherd UMC of the North.

23) This month I volunteered and represented our Police Department at the Roscommon Elementary school Book fair for an afternoon.

24) I volunteered and participated in the set up, operational time and clean-up of the 2018 Trunk or Treat hosted by the Police Department and ACT-NOW. Fantastic weather was abound and we saw a huge turnout of 1318 Trunk or Treaters and overall approximately 1500 people. This is without a doubt the best year ever in attendance. We achieved our goal of having 50 trunks participate.

11 prizes were given away at the event.

25) The Department participated in the Drug Take back and turned 64 lbs. in for incineration.

26) Our Department held a "Coffee with a Cop" event at The Bird and the Bear café here in Gerrish Township. The event was well attended and we met with many folks and yes, some we did

not know previously. We are planning another event on Dec 22, 2018. More details to follow on face book and [www.gerrishpolice.org](http://www.gerrishpolice.org).

27) Julie Hill, Lt Patchin and I met to further our work on identifying policies and procedures for replacement, modification or original drafting to get our Department into a position to apply for a Michigan Association of Chiefs of Police Accreditation review.

Additional Information:

The 10th Annual Trunk or Treat event was held on 10-31-18 in great weather conditions without incident. The event was very well supported by Community Partners to include the Police, Fire/EMS, CERT, ACT-NOW, and the Gerrish Township Board and the Roscommon County Road Commission. Without these partnerships and cooperation, these types of events would never happen. On behalf of the Police Department, I would like to extend a huge thank you to all who participated, volunteered or supported this event. A special thanks to the Co-Chairs Officer Eric Muszynski and Gerrish Township Treasurer Leasa Tulgetske.

In other news;

Our application process for the 2018 Shop with a Cop have been distributed to the Roscommon Elementary School.

After a vetting process and selection process, shopping for the 2018 Shop with a Cop program will begin in December with our Officers taking the oldest child shopping for the family and providing dinner with the Officers the same night.
