Gerrish Township Police Monthly Report 01-01-19 through 01-31-19

The Gerrish Township Police Department responded to a total of 91 calls for service for the month of January 2019.

The Department reports 6 various custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 13 total citations listing 12 traffic violations, 10 written verbal warnings, 2 misdemeanor citations and 2 felony fugitive statistics for the month. (See attached for breakdown).

Training:

The Department reports 30 total contact hours of continuing educational training. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended a Property Maintenance Committee meeting in preparation for a presentation to the board and ultimately a public hearing on a proposed Ordinance to adopt the International Property Maintenance code as well as a Property Rental regulation Ordinance within.
- 2) I attended the regular Township Board work session meeting as required.
- 3) I attended the monthly ACT-NOW Executive Board meeting in my advisory role.
- 4) I attended a meeting between Law Enforcement Administrators, Supervisors of Lyon and Gerrish Townships and the Higgins Lake Property Owners Association Riparian Committee.
- 5) I chaired and conducted two Grayson's Gift meetings to schedule and conduct business on its behalf in my interim Chair role.
- 6) I attended the monthly Roscommon County Law Enforcement Administrators meeting held at Fred's Restaurant in Roscommon, Mi.
- 7) I finalized the Ordinance to adopt the International Property Maintenance Code and Regulation of Rental Property with Attorney Hess.
- 8) I hosted a brief planning session with CERT Co-Coordinator Bob Barber to set dates and topics for the CERT team training schedule 2019.
- 9) I hosted one staff meeting this month where we trained on Road Spike usage and Pursuit Driving policy review.

10) I met with Dale Boehm from AUL to discuss Township Health Insurance costs 2019-2020 and predictions for costs.

11) I met with CERT Coordinator Bob Barber regarding the Food Truck Distribution program in Roscommon County to discuss traffic needs, flow at the scheduled truck delivery to be conducted at the Roscommon Area Public Schools Transportation building. A plan was devised and CERT would attend to assist with the needs of the group.

12) I attended the regular Gerrish Township Board meeting as required.

13) I attended a meeting with Supervisor Udy and Trustee Lippert at their request to discuss the Compost security needs and fees for such usage to support an automated system and to control costs of the removal of the product from year to year.

14) I and 4 other Officers of this Department attended a webinar to go over the Track-kit law regarding Criminal Sexual Conduct evidence kits. This is a computer system to track kits from the initial exam to the end of the case and beyond.

15) I attended and assisted with a Bowling Fundraiser for ACT-NOW and GTPD where half of the proceeds are being distributed to the RHS Boys Basketball program. The group partnered to make the event happen.

16) As a personal community service this month, I did the announcing at the Roscommon Youth Wrestling Tournament held at the Roscommon High School. Over 400 wrestlers from 5 years old to 14 years old competed from many different communities.

As a note on the bowling fundraiser mentioned above, \$1764.67 will be given to the RHS Boys Basketball Program at the half time of the Boys Basketball game on 2-4-19 by GTPD and ACT-NOW.

As I usually update the board at this time of year, I am happy to report that as we begin the year, we are fully staffed. We are beginning to work on our Organizational and Operational Goals for the next 3 years. We will begin working through this process over the course of several staff meetings. As well, I have reviewed our scheduling practices as they relate to calls for services, day and times of calls as they mingle with our current scheduling model. Our current schedule seems to be efficient both administratively and functionally on the road coverage.

I have completed my work with the MSP Michigan Incident Crime Reporting section as we transitioned from email to a web-based XML format. I just received the clearance for our 2018 data accuracy.


