## ***Gerrish Township Police Monthly Report 12-01-15 through 12-31-15***

The Gerrish Township Police Department responded to a total of 102 calls for service for the month December 2015.

The Department reports 42 total citations listing 48 traffic violations, 9 written verbal warnings, and 6 misdemeanor charge statistics for the month. (See attached for breakdown)

The Department reports 6 custodial arrests for the month. (See attached arrest report)

### Training:

A total of 32 contact hours of training and 15.50 hrs. in online training through Learn.com thus completing the required policy review for 2015 are reported for this month. (See attached detail document)

Chief Hill highlighted activity for the reported month is as follows:

- 1) I participated in the interviews of families for the purposes of vetting Shop with a Cop 2015 recipients.
- 2) I attended the Gerrish Township monthly work session as required and gave an update on police activities.
- 3) I attended the ACT NOW Executive Board meeting in my Advisory role.
- 4) I hosted and chaired the final organizational meeting for the 2015 Kids Helping Kids Christmas program for the foster children of Roscommon County.
- 5) I met with a Central Michigan University background investigator pursuant to their request regarding a prospective applicant.
- 6) I attended the Kids Helping Kids wrapping gathering for the purposes of wrapping all gifts related to the foster children of the County.
- 7) Upon request from the Michigan State University School of Staff and Command of which I am an advisory board member, I participated in interviews for vetting prospective candidates to the school.
- 8) I helped coordinate, attended and emceed the 2015 Kids Helping Kids at Christmas program as we provided gifts and evening of Christmas with Santa visit for over 50 foster kids.
- 9) The Gerrish Township Police hosted the 2015 Christmas party wrapping session for Shop with a Cop.

- 10) I attended the regular Gerrish Township Board meeting and swore in Officer James Scroggin to our Department.
- 11) I attended the monthly Roscommon County Law Enforcement Administrators meeting held at Fred's Restaurant in Roscommon.
- 12) I attended the Gerrish Township Fire Department/Gerrish Township Christmas Party held at the Streamside Restaurant.
- 13) I attended the monthly Northern Michigan Children's Assessment Center team meeting to discuss current cases.
- 14) I met with the Township Attorney once this month for the purposes of discussing Department case files.
- 15) I met with a citizen regarding a traffic citation issue.
- 16) I coordinated and arranged for the delivery of the Shop with a Cop families gifts on 12-23-15. The Department and ACT-NOW served 10 full families to include 33 children and 16 adults.
- 17) On behalf of and at the request of the Gerrish Township Board, I moderated the Dec 21, 2015 Swimmers Itch Informational meeting.

I wish to send out a big thank you from our Department to ACT-NOW for their fundraising efforts as well as our wonderful Community for their donations to make this year an incredible success for those in need at Christmas.

Please congratulate Officer Norm LaBonte for being selected as the 2015 Gerrish Township Police Officer of the year. He wears many hats in the Department and he manages to do them all justice and performs at a high level.
