that for 2016, Gerrish Township continues with the Federal Fish and Wildlife special purpose permit authorizing the lethal take of common merganser ducks and destruction of nests as defined in the permit. Gerrish Township will consider a mediation process of both Swimmer's Itch Comprehensive programs in 2017, allowing for two years of data to be compiled for Higgins Lake. This will ensure that a mediation panel has sufficient data of the SI problem on Higgins Lake, for the development of a successful program. It is not Gerrish Township's intent to remove Sicon, LLC from Higgins Lake, but to join forces for a better Higgins Lake. The 2016 program, using Northpoint Fisheries as the contractor is contingent upon securing funding in the forms of grants, donations and in kind services.

-Eric Ostergren stated that board was not paid enough for what they do. He inquired on when questions form SI meeting will be answered, inquired if board will ask the public about SI programs, inquired what Gerrish Township will do in 2 years if the special use permit is not renewed.

Frank stated he did email the US Fish and Wildlife to see the process of expanding a current permit but at this time no formal application for expansion has been submitted. -Steve Luebke inquired about the number of Common Mergansers to lethally take.

-Eric Ostergren asked if contractors would be bidding and price for harassment and lethal take.

-Ruth Mutchler inquired on if nest boxes are included in program and what grants have been considered

-Diane Wagner asked if the website would be changed to reflect both SI organizations for information and donations
