Gerrish Township Police Monthly Report 01-01-16 through 01-31-16

The Gerrish Township Police Department responded to a total of 108 calls for service for the month of January 2016.

The Department reports 28 various custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 42 total citations listing 48 traffic violations, 26 written verbal warnings, and 10 misdemeanor arrests statistics for the month. This month has seen the culmination of approximately 6 months of investigative work on various storage unit break ins and it has produced 20 felony arrests statistics based on the number of units that were broke into. (See attached for breakdown).

Training:

The department reports 49 contact hours of training this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I chaired the Roscommon County 911 Technical Board meeting and additionally was elected as chairperson again for the 2016 calendar year.
- 2) I attended the regular Township Board work session meeting as required.
- 3) I attended the monthly ACT-NOW Executive Board meeting in my advisory role.
- 4) I attended the Roscommon County LEPT meeting and presented the 2015 CERT Equipment Grant request for approval to be taken to the 7th Region Homeland Security Board for consideration.
- 5) I met with Supervisor Homola and Police Liaison Lippert at their request.
- 6) I attended the monthly Roscommon County Law Enforcement Administrators meeting held at Fred's Restaurant in Roscommon, Mi.
- 7) I held a staff meeting to discuss and strategic plan for the coming years to establish goals, objectives and actions for the Police Department. This is an ongoing process that we will visit in more staff meetings in the future.
- 8) I attended a second meeting of the month ACT NOW Executive Board to discuss and coordinate the cancellation of the planned 2016 Valentine Day Dinner dance.

9) I hosted and coordinated a planning session for the upcoming CERT Basic classes that will be held at the Police Department each Wednesday from February 17, 2016 through March 23, 2016. The class will contain the required 20 hours of CERT Basic FEMA program and add to the number of CERT volunteers we currently have.

As some further notes this month;

We are currently within one month of being up to our authorized seven full time Officers which has not occurred for a few years now. As that occurs, I hope that our schedule can settle in to the design model to offer us the best possible coverage that assists in the work load for all.

I would like to commend my Officers for their diligence throughout this transition and commitment to our mission and vision statements.

The coming months will be filled with expanding our CERT Team and our Community Policing ventures.


