Gerrish Township Police Monthly Report 06-01-16 through 06-30-16

The Gerrish Township Police Department responded to a total of 119 calls for service for the month of June 2016.

The Department reports 26 total citations, recording 24 traffic violations, 3 Misdemeanor violations, and 9 written verbal warnings. (See attached report for breakdown).

The Department also reports 2 custodial arrests for the monthly period. (See attached report for breakdown).

Training:

The Department reports 60 hours of training this month. (See attached breakdown)

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the Gerrish Township Monthly board work session as required.
- 2) I attended the ACT-NOW Executive Board meeting in my advisory capacity to the organization.
- 3) I attended the Summer Department range qualification day and qualified with our Department firearms as required.
- 4) Our Department provided officers to the Higgins Lake Saver day as we have in the past many years.
- 5) I have coordinated the changeover and re-equipping a new patrol unit for service this month. We have worked with Pro-Comm Inc. from Mt Pleasant, Mi to expedite this in the most cost effective manner.
- 6) I hosted a Higgins Lk Sunrise Run Safety Coordination meeting to ensure a coordinated event for the run that occurred on 6-18-16.
- 7) I attended the AVI coordination/planning meeting for the Charlton Heston Academy full scale exercise planned at the end of August 2016.
- 8) I attended two FFSS (Friends for Safe Schools) meeting to continue to coordinate the effort to place "The Boot" in each school building in the Roscommon Area Public Schools and other area County Schools.

- 9) I attended the Grayling Bike Tour Safety planning meeting held here at GTPD by the Roscommon County Road Commission. The event is scheduled to come through our Township on Saturday July 9, 2016.
- 10) I attended the NMCAC regular case review team meeting held at the NMCAC reviewing the current child abuse/neglect and the child criminal sexual conduct cases in County.
- 11) I attended the Roscommon County Law Enforcement Administrators meeting held at Fred's Restaurant.
- 12) I attended the CERT trailer design meeting hosted by Sgt Patchin regarding the interior design progression discussion and ultimate decisions.
- 13) I attended the MACP Summer conference and went to several training break-out sessions. The MACP Summer Conference was a Liability themed event for professional development. Topics, classes and meetings included a Financial Reality Presentation, Michigan's Sexual Assault Evidence Kit Submission Act Compliance discussion, MACP Accreditation, Regional Chiefs Meeting, Contemporary Issues in Police Liability (Hot button issues and US Appeals Circuits recent cases), Foot Pursuit issues and policy discussion. Allowing Deviant behavior in your Department liability issues, Civil Rights complaint trends and how best to address, Crime Gun intelligence, a presentation on the IBIS and Nibin Systems and their current status and needs to support and finally, How much force is too much force? Discussion of use of force current cases and trends for change.
- 14) I worked on the 2017-2018 Budget preparation as required to meet Special Assessment requirements for public hearings.
- 15) The Higgins Lake Sunrise Run went off without major incident. Over 400 runners participated in the various distances offered. We had 18 CERT Volunteers and many ACT-NOW volunteers that participated as our community was well represented.
- 16) I served as the overall Incident Command for the 7th year of the running of the Higgins Lk Sunrise Run.
- 17) I met with Township Attorney Scott Hess regarding 3 blighted problem properties that will require a civil complaint drafted to find success. All efforts to enforce our normal Junk and Garbage ordinance #16 and Junk Vehicle Ordinance #34 have not alleviated the issues.
- 18) I coordinated a planning meeting at the South Park Headquarters and additionally authored the 2016 South Higgins Lake State Park Operation plan to have a task force involving the GTPD, RCSD, DNR Law Enforcement, and DNR Parks Division. The effort will be conducted July 2 and 3, 2016 at the South State Park. We have not done a youth alcohol enforcement effort for a few years now and statistical data as well as DNR Parks Division data from 2015 indicating a rising area of concern.
- 19) I conducted one staff meeting this month to discuss open case files for coordination as well as preparation information for the coming Fourth of July 2016 weekend.
- 20) I held two internal meetings regarding equipment needs, tracking all fee based items for consideration in the 2017-2018 budget year and analyzing all insurance based items.
- 21) I met with Chris Fisher of our IT group Kodiak to begin the work on getting our email changed over to a different domain and maintaining integrity of the old ones for a period of a year while changing.

As a reminder, the 17th ACT NOW annual meeting, picnic and block party is scheduled for 7-18-16 at 6:00 p.m. at the Gazebo behind the hall. A brief Annual meeting will be held for the election of Officers for the next year for ACT-NOW. We will also be announcing the annual ACT-NOW Citizen of the Year award.

I want to remind everyone of our 7th Annual Golf Outing Fundraiser on August 13, 2016 that will be held at the Redwood Golf Course in Markey Township. Registration will be at 9:00 a.m. and shotgun start planned for 10:00 a.m. This is a major fundraiser for the ACT-NOW group and the Police Department to support various benevolent activities in the Township.
