Gerrish Township Police Monthly Report 11-01-19 through 11-30-19

The Gerrish Township Police Department responded to a total of 103 calls for service for the month of November 2019.

The Department reports 9 total citations listing 9 traffic violations, 0 written verbal warnings, and 3 misdemeanor citations. (See attached for breakdown).

The Department reports 1 Felony custodial arrests for the month. (See attached arrest report).

Training:

The Department reports 11 hours of training for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the Township Board monthly work session as required.
- 2) I was contacted by the Salvation Army Representative regarding the possibility of our Department/Public Safety ringing the bell at the Family Fare on 12-20-19 on behalf of their organization again this year. We will be participating in the event and we will ring at the Family Fare in Roscommon, Mi.
- 3) I attended the regular Gerrish Township monthly board meeting.
- 4) I coordinated the position announcement and application processing for one of the open full time Police Officer positions here at the Department.
- 5) I attended the Roscommon County Law Enforcement Administrator's meeting held at Fred's Restaurant in Roscommon, Mi.
- 6) This past month, myself and two other members of the Department are participating in the three month "No Shave" campaign to benefit the Northern Michigan Children's Assessment Center. A total of \$185.00 will be donated by Officers to the effort.
- 7) I have worked on many other Administrative issues throughout the month which were included in my Department Update report to the board at the Monthly board work session.
- 8) Peer interviews of prospective Police Officer candidates were conducted this past month.
- 9 I attended the ACT-NOW Executive Board meeting in my Advisory member role.
- 10) I conducted one staff meeting this month.
- 11) I chaired one Kids Helping Kids for Christmas meeting to provide a Christmas evening of dinner, Santa visit and gifts for foster children in Roscommon County and their families.

- 12) I met with the Prosecutor regarding secondary dissemination of LEIN documents to defense counsel during the discovery process of the case file in response to her correspondence to Law Enforcement Administrators reference their conveyance.
- 13) I arranged the presentation of life saving awards to two of our Officers conveyed by the Sons of the American Revolution. This presentation occurred at the Township Board work session.
- 14) I attended the NMCAC case review and coordination meeting of the child abuse/neglect and sexual assault in the County.
- 15) I met with the Law Enforcement Administrators and Roscommon County Emergency Managers regarding the recent competed document from the Roscommon Area Public Schools All Hazards Emergency Plans that schools were required under law to complete. The purpose of the meeting was to make sure it fit into the County Emergency Plan that is already in place and used and practiced/trained by emergency responders. Standardization of language, corrections regarding a couple of liability and legal terms and geographic maps were discussed to give feedback to the school.
- 16) In relation to #15, we met as a group with the Superintendent of the RAPS District and made the suggestions that came out of #15's meeting. We will now await the finished document to be codified with the Board of Education and subsequent copies are to come to each of our entities.
- 17) Lt Patchin and I attended a software demonstration presentation at the District court regarding on-line in a secure program called CloudGavel. The program would deliver access for search warrant documents and other court documents that are routinely used. It would connect us with the court and streamline the current processes of approval times for search warrant affidavits.
- 18) I attended a webinar this month on "How to safely communicate about suicides."
- 19) I met with the new Lieutenant from the Houghton Lake Post to promote positive relations under his new regime.
- 20) We picked up 8 applications for the Shop with a Cop program and vetted them in preparation for the shopping to begin for the 2019 Christmas season.
- 21) As always this is a very busy Community relations time for our Department and I thank my Officers for giving their time and efforts to maintain this time consuming level of service. Additionally, we are so blessed and grateful for our volunteers now and throughout the year which help make it all possible.

In other news for upcoming events to note;

Wrapping of the Kids Helping Kids Foster Kids Christmas gathering will occur on Sunday December 8, 2019. The gifts are wrapped by many students from different organizations throughout the County as we prepare for the Saturday Dec. 14, 2019 Foster kids Christmas 2019.

On December 16, 2018 at 5:00 p.m., we will be having our annual SHOP-WITH-A-COP "WRAP PARTY" at the Police Department. Pizza and pop will be served afterwards.

The Police Department and some ACT-NOW members will be delivering the Shop with a Cop gifts for Christmas on or about December 23, 2019.
