Gerrish Township Police Monthly Report 01-01-20 through 01-31-20

The Gerrish Township Police Department responded to a total of 101 calls for service for the month of January 2020.

The Department reports 2 custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 7 total citations listing 6 traffic violations, 5 written verbal warnings, and 1 misdemeanor citations for the month. (See attached for breakdown).

Training:

The Department reports 82 total contact hours of continuing educational training and 7 hours of on-line training for LEIN requirements. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I analyzed and prepared the 2019 Police Department Annual Report.
- 2) I attended 2 ACT-NOW Executive Board Meetings in my advisory capacity this month. The second meeting was the Annual 2020 planning meeting to map out a course to another successful fundraising schedule as well as scheduling the events for goal dates for the group.
- 3) I attended an 8 hour professional development training entitled Managing the Incident Command Post and Tactical Operation Command in Cadillac put on by the National Tactical Command Officers Association. This class focused on large scale Mass Casualty incidents and the breakdown of same to manage to a success.
- 4) I conducted two staff meeting this month to focus on our continued success with managing open case files and discussing important Department personnel shortage issues that we face at this time. Additionally, we conducted LEIN required re-certification training. As well, we re-certified in the Conducted Electrical Weapon (Taser) as required.
- 5) I attended the monthly Handle with Care meeting to further discuss the progress of the program as we continue to roll out various components to further the communications of the children that have experienced trauma.
- 6) I attended the regular Township Board work session meeting as required.

- 7) I attended the Michigan Association of Chiefs of Police Executive Board Meeting via conference call this month.
- 8) I attended the monthly Roscommon County Law Enforcement Administrators meeting held at Fred's Restaurant in Roscommon.
- 9) I hosted a planning session with CERT Coordinator Bob Barber and CERT member Mike Briggs to set dates and topics for the CERT team training schedule for 2020. We also met to plan and set dates for a CERT Basic 20 hour class to be held at GTPD beginning January 15, 2020 and run for 6 weeks on Wednesdays each week.
- 10) I attended the multi-discipline team meeting that examines child sexual abuse and child abuse cases that run through the Northern Michigan Children's Assessment Center each month.
- 11) I met with Dale Boehm from AUL to discuss Township Health Insurance costs 2019-2020 and predictions for costs.
- 12) I set up and hosted a meeting between the Roscommon County Emergency Manager, GTFD Fire/EMS Chief and representatives of the Good Shepherd United Methodist Church of the North for the purposes of providing them with a EOP template to organize their responses in the event of large emergencies (all hazard) and to correlate with their security and key staff during that time.
- 13) I attended a 4 hour Legal Update class with the entire department at the Northern Michigan Law Enforcement Training group headquarters at Camp Grayling.
- 14) I attended and chaired the Roscommon County 911 Technical Board meeting held at the County Building. Reviews of policies at the beginning of each year were on the agenda.
- 15) I was re-elected as the chair of the 911 Technical Board again for the 2020 year.
- 16) I attended the regular Gerrish Township Board meeting as required.
- 17) I instructed the first night of the 2020 CERT Basic class on CERT organization, policy and operations.
- 18) I met with Lt Patchin and Administrative Clerk Hill to work on the remainder of our GTPD SOP's to make sure all are updated, relevant and we are ready to begin the new book formalization and numbering system in whole.
- 19) I met with the committee to re-work the general Township Policy Manual and Handbook. We went over the remainder of what we had left to cover before the re-working of those books. We continue on course for a self-imposed deadline of June 2020 to present to the full board for approval.
- 20) I attended a human resources class with Clerk Patchin put on by the Michigan Townships Association.
- 21) I attended a meeting with FirstNet (AT&T) at the Gerrish Township Fire Hall to review their proposals for Band 14, Public Safety dedicated Band for cell service. Currently we use the Verizon product cell service. FirstNet would provide non-preempted coverage to all first responders throughout the country at a very good governmental rate. FirstNet and AT&T have a 25 year contract with the Federal government to develop and complete this seamless service. We have ordered two test phones to test service versus our current Verizon coverage area and consistency.
- 22) This past month, I attended and signed on for three more years of partnership with the NMCAC as this past 3 years has been very successful in providing better service and conviction success for our child abuse, neglect and sexual assault cases here in a four county area. I am proud of this partnership.
- 23) I attended an Emergency Operations Plan Training at the Roscommon County Commissioners room with the Roscommon County Sheriff Department to go over the latest maps and strategies for the plan.
- 24) I attended the first meeting of the Law Enforcement group relating to the beginning roll out of the new Motorola CAD/JMS/RMS system. More to follow on meeting dates, live roll out dates etc.

25) This month saw the culmination of the Project Tracks effort. The Ranger is now finished with the Tracks on same and all required data and closure of grants obtained have been completed. If anyone has not seen it, we will take the time to show it to anyone in the public. A huge thank you to the community for its support.

26) I met with Lt Patchin and Jason Jansen from Building and Zoning to go over the case file management system we will use to secure compliance with the Long Term Rental Ordinance enacted last year in the Township.

As a note, we participated in the three month long "No Shave" campaign with area Police Departments and were able to donate \$1585.00 to the Northern Michigan Children's Assessment Center to further efforts with our children in the community.

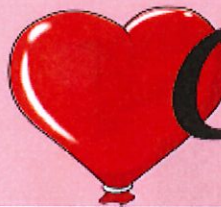

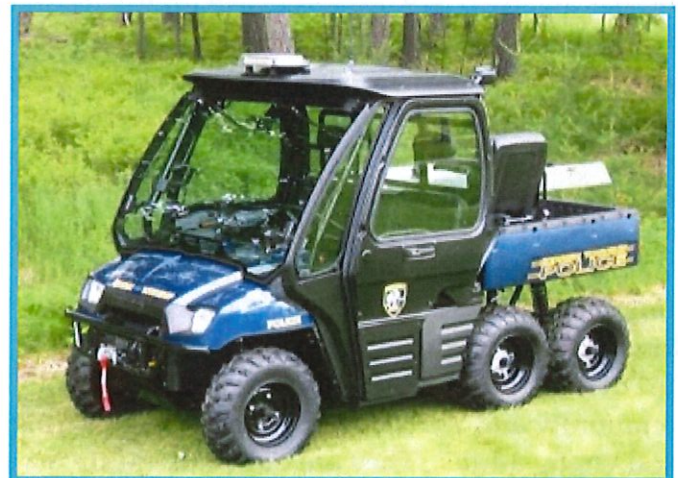


"PROJECT TRACKS"

Lt. Greg Patchin (Gerrish Twp. Police Department) wrote two grants last fall and were awarded funds through the Higgins Lake Foundation Community Grant program and the Roscommon County Community Foundation's Morley Foundation Fund, Doug Allen Fire & EMS Fund and the Roscommon County General Fund.

The Gerrish Twp. Police Department and Fire/EMS Department, along with community partner organization ACT-NOW provided the additional funding needed for purchasing and installing a "TRACK" system on the Police Department's existing Polaris Ranger off-road special response vehicle. The tracks will allow for emergency response and rescues in difficult terrain not only during snowy winters but also on hills, uneven wooded areas and swampy marsh areas. More traction would provide for greater stability and the vehicle will have more ground clearance to be able to clear deeper snow and standing water/mud. This vehicle is available for use for the Gerrish Twp. Police Department and Fire/EMS Department for search and rescues, injuries or accidents in areas where ambulances cannot reach such as sledding hills and frozen water, stand-by services at large community events as a patrol and transport vehicle.

The Ranger has been utilized in many incidents since it was obtained originally through a U.S. Smokeless Tobacco Company grant written by Chief Hill in 2007. Additional equipment was added such as the Freedom Cab and the rear Stokes Carrier and Jump Seat. Now most recently with the addition of the Tracks System, this specialized vehicle becomes one of the only of its type in our County. It will be available for call-outs to our neighboring agencies through mutual aid whenever necessary and will further benefit our community and visitors to our area.
