### ***Gerrish Township Police Monthly Report 02-01-20 through 02-28-20***

The Gerrish Township Police Department responded to a total of 103 calls for service for the short month of February 2020.

The Department reports 7 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 25 total citations listing 23 traffic violations, 1 Misdemeanor violation, 1 verbal warning and 1 Felony issued for the month. (See attached for breakdown).

#### **Training:**

A total of 79 contact hours of training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) Lt Patchin and I attended the Michigan Association of Police Chiefs mid-winter conference and took various training classes available.
- 2) I attended the regular Gerrish Township Board meeting as required.
- 3) I attended the Michigan Association of Chiefs of Police Legislative Committee while at the conference mentioned above where I reported out on my two bill assignments for the organization position. We also discussed many other pending legislative pieces to affect Law Enforcement. Positions were developed and communicated to the Legislators.
- 4) I also attended the Northern Michigan Association of Chiefs of Police meeting discussing local issues and providing Legislative update for the MACP to the group.
- 5) I was elected chair of the 911 Technical Board meeting for the 2020-2021 year. This is a position I have held for many years. At this month's meeting, I turned back in the policies that we were given for review for review and implementation into the 2020 policy updates to the Center.

- 6) The Department conducted 3 lockdown drills at the Roscommon Area Public Schools pursuant to their request.
- 7) I facilitated and attended a department staff meeting this month for re-certification of our American Heart Association First Aid.
- 8) This month, we conducted 4 of the 6 required CERT Basic Training classes required to be a CERT member in Gerrish Township. We graduated 2 CERT members who will be great additions to our team. The Department is still looking for volunteers who wish to become members.
- 9) I attended the Regular Gerrish Township Board Meeting as required.
- 10) I hosted a final debriefing meeting for the purposes of closing the books on the 2019 Kids Helping Kids at Christmas, Foster kids Christmas event held each year in collaboration with many community sponsors.
- 11) I attended the monthly multi-disciplinary Child abuse, neglect and CSC team meeting at the NMCAC.
- 12) This month I facilitated and was a liaison with ACT NOW to arrange a propane full tank delivery to an elderly bed-ridden Township resident who was unable to pay for home heating. We provided a full tank fill through Ameri-Gas in Roscommon, Mi.
- 13) I attended the LEPC/LEPT meeting on behalf of the Police Department to further the growth of our County Emergency management system and abilities.
- 14) I facilitated and hosted key players in the St Hubert's and St James Catholic Churches to assist them with gaining an Emergency Operation Plan that is consistent with the Roscommon County Emergency Management system. Discussed, answered questions and also provided a template to the groups to work through in their buildings. Future meetings will occur to further the process to prepare for an AVI or other emergencies that could occur. This was done in partnership with the County Emergency Manager and the Sheriff.
- 15) As a member of the Insurance benefits committee for the Township, I attended a meeting with Clerk Patchin and our current carrier representative Dale Boehm of Boehm-Tarrant Associates to discuss his proposals for the 2020-2021 Insurance year regarding Health/RX, Vision and Dental Benefits. A recommendation was drafted for consideration to the Township Board.
- 16) We hosted another Coffee with a Cop which was requested by popular citizen comments. We had 58 people attend the event held at The Bird and The Bear Grill LLC. We had a great one-on-one exchange with the members of the community that came out and will schedule more in the future.
- 17) This month saw our CPR/AED instructor/Administrative Clerk conduct 2 re-certification classes for the AHA CPR/AED to our CERT members and one new CPR/AED class to new CERT members and a few citizens that needed renewal.

18) Due to the primary elections, I attended 2 Gerrish Township Board work sessions where I presented our work session report.

19) Lt Patchin represented our Department at a collaborative meeting at the RAPS Middle school to discuss the FAST program being deployed at the Schools this year to address mental health concerns for students while at school. Solutions for a more communicative plan regarding safety plans etc. were discussed.

20) This month also saw the 2016 Ford Explorer Patrol car have an engine to be replaced as same was blown. Much coordination work went into the fixing of same.

21) The Department Administrative Clerk and I have met 4 times this month for the purposes of furthering the work of the General Township Policy and Handbook reform Committee. The work is coming along well and we will continue to do the minutia work in the coming months to complete the project by June 2020 for presentation and consideration by the full board.

A look ahead for ACT-NOW/GTPD and CERT happenings;

3/11/20 - We will be conducting CERT 1st quarter training from 1800-2000. The training will be on CERT and Flood preparedness and Annual Bag Check. It will be held at the Gerrish Township Hall.

4/15/20 - The Police Department and the CERT team will be participating in the Statewide Emergency Operations Center Flood Simulation disaster. The exact time is still TBA, but will occur during the day and the EOC will be activated and an exercise for CERT will be included in the plans.

4/18/20 - The Department and ACT-NOW will be having a Bowling Tournament Fundraiser at Fred's in Roscommon, Mi to benefit ACT NOW programs and the Roscommon High School Bowling Team. Look for flyers soon.

5/4/20 @ 1800 hrs - The Department and ACT-NOW will present two \$1000.00 scholarships at the Roscommon High School Senior Awards Night Program.

5/19/20 - Spring Road Clean-up is scheduled for our section of Co Rd 100 from Pioneer Hill South to Hillsdale Road. Begins at 4:00 p.m. with a start at Gerrish Township Police Department and Pizza and pop will be served when done at the PD. Public Welcome!

5/20/20 - ACT NOW/GTPD and CERT will be at the Roscommon Business Expo from 3:00 p.m. to 6:00 p.m.

5/21/20 - Alternate (Rain date) for Spring Road Clean-up. Same times and benefits☺
