### ***Gerrish Township Police Monthly Report 06-01-20 through 06-30-20***

The Gerrish Township Police Department responded to a total of 158 calls for service for the month of June 2020.

The Department reports no custodial arrest statistics this listed period due to COVID-19 procedures and jail lodging requirements. (See attached report for breakdown).

The Department reports 21 total citations listing 20 traffic violations, 1 verbal warning for this listed period. (See attached for breakdown). Again COVID-19 protocols in place for traffic stops.

#### Training:

83 contact training hours are reported during this listed period. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the ACT-NOW Executive Board meeting in my Advisory role.
- 2) I attended the Gerrish Township Board work session as required to update the board on the operational status of the Department.
- 3) The Department and ACT-NOW awarded two \$1000.00 scholarships to two graduating seniors of the Roscommon High School.
- 4) I attended a three day training on the Motorola Flex CAD/RMS/JMS integration project. This training was also attended by Lt Patchin and Administrative Clerk Julie Hill. The training was hands on and involved setting permissions, parameters and registry work on the program itself to better fit our needs for the future. The work will continue all of 2020 with hopes of a target roll out for go live in April 2021.
- 5) I met with area Law Enforcement partners regarding the South Higgins Lake State Park for the purposes of discussing the Fourth of July potential activity at the Park and a needs assessment for an enforcement effort at the Park year. In reviewing the data from last years no special enforcement provided, Law Enforcement felt that the expenditure for an event was necessary, however due to tight budgets, we agreed to a scaled down version of two years ago response and task force.
- 6) An operational planning session was conducted here at the Police Department to assign staff to the South Higgins Lake Operational Task force for 2020.
- 7) I attended two Roscommon County Law Enforcement Command meetings held via an electronic media as we have for some months now due to the COVID-19 protocols.

- 8) I attended a meeting at the Markey Township Hall at the request of Undersheriff Ben Lowe regarding our PA 56 of 2012 Enforcement dock permit processes as Markey is considering their role as it relates to Houghton Lake. As Gerrish Township's plan is considered a best practice plan since the inception of PA 56 in 2012.
- 9) I attended a MACP Legislative Meeting in my role as a member of this committee that reviews and assesses positions on current legislation that effects Law Enforcement in Michigan. This meeting was held via an electronic media as well.
- 10) I met with the board this past month for the purposes of reviewing my proposed 2021-2022 Police Department budget. The budget needs prepared far in advance in preparation of special assessment statutes that require certain public review times.
- 11) I had one command meeting this month to discuss operational concerns to continue with goals of quality, timely, professional police services.
- 12) I also amended our Use of Force Policy to reflect a duty to intervene which is a recommendation that has come out of the recent National spotlight on Law Enforcement.
- 13) I also implemented a policy entitled Fair and Impartial Policing as recommended by the International Association of Chiefs of Police.
- 14) In relation to items 12 and 13 above, the Department reviewed the policies and trained on the practical application of their value.
- 15) I provided Incident Command for the continued Food Distributions being held at the Roscommon Area Public Schools Bus Garage. There are several partners that we work with to accomplish these each month. Due to COVID-19 they have been extended into the summer. The Gerrish Township CERT team helps us provide the necessary traffic direction and flow to keep all visitors in their cars to make provisions for COVID-19 precautions.
- 16) I attended the Northern Michigan Children's Assessment Center multi-disciplinary team meeting of all Child Sexual Abuse and Child Neglect and Abuse cases to make sure each agency is participating seamlessly in the files to assure our children are getting the best care possible and we are able to support successful prosecution of offenders in these cases.
- 17) This month I met with Supervisor Udy, Roscommon Road Commission manager Tim O'Rourke and two citizens regarding an alleged dangerous condition at Co Rd 200 and N. Townline Rd.
- 18) I met with Supervisor Udy, Trustee Lippert, Lt Patchin, Building and Zoning Administrator Janson and the Township Attorney to discuss various legal issues in the Township that need attention.
- 19) Lt Patchin attended the LEPT (Local Emergency Planning Team Meeting) on my behalf this month.
- 20) Late in the month, our long awaited (ordered over 10 months ago) 2020 Ford SUV AWD patrol unit arrived and we were able to get same equipped and graphics lettered in a short order to be in service by the 4<sup>th</sup> of July weekend. A thank you to Pro-Comm Inc. out of Mt Pleasant for the quick turnaround and New Century Signs in Gaylord, Mi. for their response in getting the graphics printed and installed.

Highlights this month for the Department include;

We have had many cancellations of our usual Community collaborative projects. The Higgins Lake Sunrise Run, fell victim to the COVID-19 precautions in this month specifically. We look forward to next year's event and partnership.

Also, our ACT-NOW/GTPD Golf Outing fundraiser is cancelled for August 2020 due to COVID-19 as well. We look forward to next year and miss the public attendance in that event as well.

We will be having our ACT-NOW Annual Meeting at the Gerrish Township Hall at the Pavilion outside behind same on 7-20-20 at 6:00 p.m. Due to COVID-19, there will be NO picnic/potluck this year. Please bring a lawn chair and provide social distancing accordingly. If it rains, we will go into the hall, also respecting social distancing.
