Gerrish Township Police Monthly Report 09-01-20 through 09-30-20

The Gerrish Township Police Department responded to a total of 116 calls for service for the month of September 2020.

The Department reports 3 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 10 total citations listing, 9 traffic violations, 2 misdemeanor violations, 1 Felony and 5 written verbal warnings. (See attached for breakdown).

Training:

A total of 68 hours of training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the ACT-NOW Executive Board meeting in my advisory capacity.
- 2) Our Department held the ACT-NOW/GTPD annual road cleanup. We clean the area on both sides of the road on Co Rd 100 from Pioneer Hill to Hillsdale Dr twice a year. 15 Bags of trash were collected.
- 3) I attended the Gerrish Township Board work session via electronic media as required and gave a Department update on Police Department activities.
- 4) I held two staff meetings this month to go over all open case files for discussion and to fulfill various training needs.
- 5) I attended the regular Gerrish Township Board electronically as required.
- 6) I attended a meeting of the Higgins Lake Property Owners Association Riparian Committee to discuss the summer as it relates to law enforcement, Dispatch and improving PA 56 enforcement and riparian issues.
- 7) I attended the two Roscommon County Law Enforcement Administrators electronic meetings as we have been doing since the Covid-19 pandemic for Law Enforcement consistency.
- 8) I met with Lt Patchin to discuss a plan and timetable for recruiting and hiring one full time police officer position.
- 9) I hosted an original Trunk or Treat 2020 meeting to further the process of completing the detail of this year's event to be held Oct 31, 2020 as a drive through event during Covid-19.

- 10) This month I participated in two meetings regarding creating one General Township Policy Manual/Handbook document. We are nearing completion of the review work and then a final draft will be forwarded to the Township Board for review and subsequent action.
- 11) I met with command staff to make sure we are comfortable with our work flow processes at this time.
- 12) This month, I hosted a Kids Helping Kids at Christmas organizational meeting to discuss how to have the event and yet comply with Covid-19 as well as discussing necessary grant applications to keep funding in place for same during these challenging times.
- 13) I attended both the MACP Legislative and Executive Board meetings by electronic media this month pursuant to my board positions for the group.
- 14) I attended the NMCAC multi-disciplinary team case review of the cases in the center. The team reviews Child Abuse/neglect and CSC cases.
- 15) I met with the Township Attorney this month for the purposes of moving forward on several failing to comply suspects with Ordinances that have been worked on by this Department in the past several months.
- 16) This month saw the purchase and implementation of a software vendor to supply our Department with on-line relevant training topics to policing in America 2020. The system tracks the courses taken and reports them automatically to our licensing body MCOLES. Previous to this program, we have been entering data manually.
- 17) The department finally received all the new, next generation Motorola Apex portable and mobile radios that we ordered 6 months ago. The radios have been properly assigned accordingly and are now in use.
- 18) This month, the entire Department completed Firearms range and classroom training required by MCOLES with the use of all authorized and issued firearms in use by this Department successfully.
- 19) This month, Lt Patchin completed his required 8 hour Local Area Security Officer (LASO) recertification to police the LEIN use in our Department per LEIN policy requirement via an electronic media.
- 20) This month, Administrative Clerk Julie Hill attended a FOIA virtual training for the purposes of reviewing new updates to the statute and procedures.
- 21) This month, we provided Traffic Control and event support for the Monthly Food Distribution by the Roscommon Area Christian Ministry held at the RAPS campus without incident as we have been doing throughout Covid-19.

A look ahead;

- Saturday, October 31, 2020, we will host the 12th Annual Trunk or Treat at a changed venue of the RAPS Campus using the schools infrastructure to support a drive through no contact approach this year in consideration of Covid-19. The Trunk or Treat will be from 6:00 p.m. to 7:30 p.m. with Trunks being requested to be set up beginning at 4:15 p.m. For the people that bring a vehicle and participate in the Trunk decoration for Trunk or Treat there will be prizes for the Best Decorated Trunk, Most Creative Trunk and Scariest Trunk. There will also be 10 random participation drawings this year participants.
The event is being organized by a committee led by Officer Eric Muszynski and various Gerrish Township Police Officers assisting. Please help us by bringing your cars down,

decorate your trunks and cars and provide candy for the trick or treaters ahead of time at the Gerrish Police and the Gerrish Township Hall.
