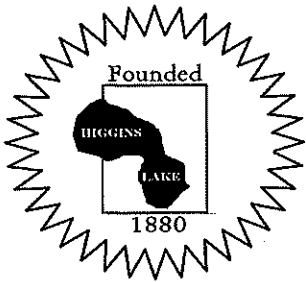

- On Friday October 10<sup>th</sup>. I attended a special board meeting to discuss township zoning issues.
- I assisted Clerk Patchin with the Public Accuracy Test on township election equipment on Thursday October 22.
- I met with residents on Friday October 23 to discuss progress on the sanitary sewer project.
- I attended the regular monthly township work session on Thursday November 5 to prepare for tonight's meeting.
- I assisted Marina Manager Steve Myer, and marina employee John Oman with the removal of items used to illegally moor boats in front of the Gerrish Township Park on Friday October 6<sup>th</sup>. Lt. Greg Patchin was on-site to assist with locating the items for removal.
- This morning I attended the monthly Roscommon County Transportation Authority board meeting. The Authority has been awarded grants for new driveway paving and additional shelter for the bus fleet.
