### *Gerrish Township Police Monthly Report 02-01-21 through 02-28-21*

The Gerrish Township Police Department responded to a total of 67 calls for service for the short month of February 2021.

The Department reports 3 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 9 total citations listing 6 traffic violations, 4 Misdemeanor violations, 5 verbal warnings issued for the month. (See attached for breakdown).

#### Training:

A total of 163 hours of training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) Lt Patchin and I attended the Michigan Association of Police Chiefs mid-winter conference and took various leadership training classes available.
- 2) I attended the Michigan Association of Chiefs of Police Legislative Committee while at the conference mentioned above where I reported out on my bill assignments for the organization to review a position. We also discussed many other pending legislative pieces to affect Law Enforcement. Positions were developed to communicate to the Legislators.
- 3) I also attended the Northern Michigan Association of Chiefs of Police meeting discussing local issues and providing Legislative update for the MACP to the group.
- 4) This month, I presided over two Northern Michigan Children's Assessment Board meetings in my Chairpersons roll to conduct the business of the center.
- 5) I met with new Township Trustees Newton and Oppy for the purposes of familiarizing them with the Department's budgeting mechanics, objectives, and goals and to further their knowledge on our revenue streams and usual expenses associated with Police Department operations.

- 6) I participated in three project management calls regarding the on-going status of our Motorola Flex CAD/RMS/JMS progress to include technology issues yet to overcome as well as the scheduling of Officers for end user trainings needed before a go live date of April 20, 2021.
- 7) I attended the Gerrish Township Board work session as required via electronic media.
- 8) I attended two Roscommon County Law Enforcement Administrators meeting to discuss local issues.
- 9) I attended the ACT-NOW Executive Board meeting in my advisory board member role to further plan for potential fundraisers in 2021.
- 10) The entire Department received the second COVID-19 vaccine as scheduled and all are doing well with no work time lost due to any side effects.
- 11) I attended the Local Emergency Planning meeting via an electronic media for the purposes of discussing the needed items for Emergency Management for the County required plans.
- 12) We conducted one staff meeting this month where we continued to work in the Motorola Flex Learning Management System in preparation of end user training in the system as well as coordinating all open case files for status and comment.
- 13) I attended a brief webinar with Clerk Patchin and Fire/EMS Chief Fisher on the ArchiveSocial program to learn how to extract data as needed when FOIA requests are received.
- 14) Lt Patchin, Julie, and I attended the Patrol Suite end user training for the Motorola Flex CAD/RMS/JMS as required.
- 15) Lt Patchin, Julie, and I attended the Records Suite training for the Motorola Flex CAD/RMS/JMS as required.
- 16) I met with Clerk Patchin, Jason Jansen and Attorney Hess to discuss an open litigation matter at the Township regarding a zoning issue.
- 17) This month, the Health Insurance Committee (Clerk Patchin, Fire/EMS Chief Fisher and I) met for the purposes of looking over the 2021 Health Insurance with the Township's carrier to ultimately recommend a plan for the Township Board's approval at the March 2021 regular Board meeting as our policy expires in May 2021.
- 18) I met with a prospective Police Officer Candidate to review his resume, application, goals, and plans. Our Department is seeking to fill a position that has been open since October 2019.
- 19) The Department once again supplied traffic safety for a COVID-19 conscious Food Distribution held at the RAPS Campus by the Roscommon Area Christian Ministries. This month 308 families, 672 individuals were served with 25 pallets of food totaling 17, 516 lbs.


