Gerrish Township Police Monthly Report 08-01-21 through 08-31-21

The Gerrish Township Police Department responded to a total of 143 calls for service for the month of August 2021.

The Department reports 4 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 23 total citations listing 19 traffic violations, 1 Felony violation, 2 misdemeanor charges, 8 verbal traffic warnings, 1 Public Act 56 Boat Mooring violation and 2 Fireworks Ordinance Violations (See attached for breakdown).

Training:

The Department reports 13 hours of training this month.

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the monthly Gerrish Township Board work session via Teams format and briefed the board on Department issues.
- 2) This past month, Julie Hill, CPR/AED instructor for Police/Fire and EMS provided Basic CPR/AED certification class for Roscommon Area Public Schools staff that required same. 13 people were instructed.
- 3) I met with Attorney Hess this month with regards to outstanding case files for attention.
- 4) I held two staff meetings this month to discuss all open case files and coordination on same as well as future scheduling issues.
- 5) I attended two Roscommon County Bi-monthly Law Enforcement Administrator meetings via electronic format.
- 6) I prepared a budget and presented same at the Police Department Special Assessment Hearing as required for our 2022-2023 budget year.
- 7) This month, I assigned the new Arrest Management Policy for training on our on-line training solution Virtual Academy.
- 8) Lt Patchin, Julie Hill, and I met with representatives of Motorola at their request and the County 911 Director's request regarding our concerns and issues with the proposed system for the CAD/RMS/JMS training, roll-out and deficiencies

causing us to be very uncomfortable to move forward with the collaborative project.

- 9) Lt Patchin conducted the third quarter training with CERT with the topic being the CERT trailer familiarization, operational set-up; and trailering.
- 10) This month, I met with a citizen regarding short term rental complaints. I updated them on the status of the proposed State bills and the fact that the Township currently has no ordinances to address short term rentals specifically.
- 11) This month, I took in two vendor presentations looking at body worn camera technology in preparation of writing the Federal small agency grant to possibly obtain \$2000.00 a person to deploy this technology. The companies were Getac and Motorola solutions.
- 12) The Department applied for the above referred to grant to seek out the funding to possibly address our lack of body worn camera technologies.
- 13) As requested by the Chief Judge for Roscommon and Ogemaw Counties, I attended a meeting to evaluate the effectiveness of the practices adopted by the Michigan Supreme Court during the Covid-19 pandemic.
- 14) I attended the Kirtland Community College Advisory Board meeting to meet the new Academy Director and hear proposed changes in the Academy Instruction.
- 15) I attended the NMCAC Multi-disciplinary team case review regarding all child neglect and abuse cases that have had interviews or services conducted at the center.
- 16) I attended and worked the ACT-NOW/GTPD Golf Outing fundraiser where the event netted \$4000.00 for our benevolent community projects.
- 17) I attended the Local Emergency Planning Team meeting in my role as a member of that group that meets to discuss and meet Emergency Management goals for our County.
- 18) I met with an MSP Background investigator seeking information on a perspective candidate of theirs for hire.
- 19) I attended the quarterly Handle with Care meeting to coordinate student referrals to the program as we have done for a couple of years now. The form was changed slightly and reproduced for our Officers use at the time of need.
- 20) Lt Patchin and I met with other Township, County and State Police partners at the MSP Post. The purpose of the meeting was to work with Northern Lakes Mental Health in their new proposed program to deploy iPads in our patrol units to be used when mental health/psyche calls come in and the individual wants to access mental health. Officers could contact the on-call worker and immediately hook up the individual with a worker for a 15-minute screening via the device in an electronic format to assist them while they are in crisis.
- 21) I conducted a Northern Michigan Children's Assessment Center monthly board meeting in my chairperson role to conduct the business of the center.
- 22) This month, Sgt LaBonte, Officer Stachurski and I attended the Roscommon County Victim Services Golf Outing on behalf of our Police Department and Officer Association.
- 23) I provided Incident Command and the Gerrish Township CERT team and Police Department arranged the traffic safety plan for the monthly Roscommon Area Christian Ministries/DHHS food distribution held at the RAPS School Campus in the Township.

In other news,

- The Department will be hosting and participating in a Glow Golf Fundraising Event with ACT-NOW to be held on September 11, 2021, at the Ye Olde Country Club in Gerrish Township. All proceeds go to our community for benevolent activities. Thank you to all that have registered already to play and join us for some great outdoor fun while raising monies for great causes locally. There is still room for one or two more teams. Contact Administrative Clerk Julie Hill for more information.
- The Department Law Enforcement Special Olympics local Torch Runn will be on September 15, 2021, with registration at 5:00 p.m. at the Gerrish Township Police Department. The run will commence at 6:00p.m. sharp and travel from the Police Department to the South Higgins Lake State Park Gazebo, at the boat basin. Food will be available at the conclusion of the run and transportation from the Gazebo back to the Police Department is being provided by the RAPS transportation department. Please come and join us for the run. There is a fee of \$30.00 which entitles the run/walk or bikers to a run day edition of a Torch Run shirt. All proceeds go to the Special Olympics of Michigan with half of our locally raised funds to our local Special Olympics athletes to off-set their costs to go to the Michigan Special Olympics.
