Gerrish Township Police Monthly Report 02-01-22 through 02-28-22

The Gerrish Township Police Department responded to a total of 91 calls for service for the short month of February 2022.

The Department reports 4 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 7 total citations listing 2 traffic violations, 2 Misdemeanor violations, 4 Civil Infractions and 1 verbal warning issued for the month. (See attached for breakdown).

Training:

A total of 48 hours of training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) Chief Hill attended the Michigan Association of Chiefs of Police mid-winter conference and took various leadership training classes available.
- 2) I also attended the Northern Michigan Association of Chiefs of Police meeting discussing local issues and providing Legislative update for the MACP to the group in my Executive Board Trustee role.
- 3) This month, I presided over two Northern Michigan Children's Assessment Center Board meetings in my chairpersons role to conduct the business of the center as well as a one on one telephone meeting with the Center's Strategic Planner to assist in the construction of a Strategic Plan for the coming years.
- 4) I met with Lt Eric Tiepel of the Roscommon County Sheriff's Department to review our current Records Management System Caliber Public Safety On-line. The review is for future knowledge and consideration as we work through a collective decision for joint CAD/RMS/JMS project for the future.

- 5) I attended the Gerrish Township Board work session as required to review the monthly operational status of the Department.
- 6) I attended the Roscommon County Law Enforcement Administrators meeting held monthly at the Fred's Restaurant in Roscommon, Mi. to discuss local issues.
- 7) I attended the Local Emergency Planning meeting for the purposes of discussing the needed items for Emergency Management for the County required plans.
- 8) We conducted two staff meetings this month to discuss operational issues to include scheduling, case management, etc.
- 9) This month I met with our CERT Coordinator Bob Barber to plan the quarterly training exercises for the Gerrish Township CERT Team.
- 10) This month Chief Hill attended the Child Death Review Team meeting to review two deaths in the County since we last met.
- 11) This month, the Health Insurance Committee (Clerk Patchin, Fire/EMS Chief Fisher and I) met for the purposes of looking over the 2022 Health Insurance with the Township's carrier to ultimately recommend a plan for the Township Board's approval at the March 2022 regular Board meeting as our policy expires in May 2022.
- 12) We held a Kids Helping Kids debriefing meeting to discuss the event successes and things that could be done better next year. Those items will be addressed in an August 2022 organizational meeting. The program remains very healthy financially.
- 13) The Department once again supplied traffic safety for a COVID-19 conscious Food Distribution held at the RAPS Campus by the Roscommon Area Christian Ministries.
- 14) Chief Hill met with Probate Court officials and other Law Enforcement leaders to discuss the need for having a "holdover room" staffed for juveniles that have been detained and awaiting adjudication the next morning. Law Enforcement officials were asked if Officers from the various local Departments would make Officers available at their contractual police overtime wages to fulfill the attendant requirement. Departments advised that they would inquire of their work forces and another meeting would be scheduled to see if there could be a voluntary list compiled of Officers willing to function in that environment and on their off time. No mandatory requirement from any Department would be entertained.
- 15) Our Administrative Clerk Julie Hill who is also our CPR/First Aid and AED instructor provided classes in the community as community outreach to the Roscommon County Juvenile Detention Center employees and members of the First Congregational Church in Roscommon, Mi.

A look ahead for ACT-NOW/GTPD and CERT happenings;

3/26/22- We will be assisting the next regularly scheduled Food Distribution at 1000 hrs. at the RAPS Campus.

4/15/22 - The Police Department and ACT-NOW will be re-opening our Scrap Metal Project.

5/22/22- The Department and ACT-NOW will present two \$1000.00 scholarships at the Roscommon High School Senior Awards Night Program.

5/17/22 - Spring Road Clean-up is scheduled for our section of Co Rd 100 from Pioneer Hill South to Hillsdale Road. Begins at 4:00 p.m. with a start at Gerrish Township Police Department and pizza and pop will be served when done at the PD. Public Welcome!

5/24/22 - Alternate (Rain date) for Spring Road Clean-up. Same times and benefits☺
