Gerrish Township Police Monthly Report 03-01-23 through 03-31-23

The Gerrish Township Police Department responded to a total of 153 calls for service for March 2023.

The Department reports 4 custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 29 total citations listing 19 traffic citations, 3 misdemeanor citations, 4 Civil Infractions and 5 written verbal warnings. (See attached for breakdown).

Training:

The Department reports 89 hours of continuing education this month. (See attached document).

Chief Hill highlighted activity for the reported month as follows:

- 1) This month, Julie Hill, our certified CPR/AED instructor supplied classes for 5 of our CERT Team members for renewal of CPR/AED and one skills assessment for a local Doctor that needed same.
- 2) I attended the ACT-NOW Executive Board meeting in my advisory role to the group.
- 3) I attended the Gerrish Township Annual, Regular, and General Budget meetings.
- 4) This month I chaired the 9th District Michigan Association of Chiefs of Police meeting in Clare, Mi. as a Past President for the purposes of electing the 9th District Representative for the group that will sit on the MACP Executive Board.
- 5) I attended the Gerrish Township Board work session as required.
- 6) I attended the NMCAC multi-disciplinary monthly meeting for the purposes of reviewing current child abuse and sexual assault cases that the center has been working on.
- 7) This month I attended a Trust Meeting to discuss Handle with Care notifications and how the process is progressing.
- 8) I attended the Roscommon County Commissioners work session meeting upon invite of Commissioner Ostergren. The purpose was to hear a presentation from a 2nd Amendment group lobbying the County Commissioners to become a "Sanctuary County" for 2nd Amendment gun rights.
- 9) I met with Sgt LaBonte to go over his evaluation for 2023 and discuss his goals and the Department operational objectives as they relate to same.

- 10) I attended the Michigan Association of Chief of Police Legislative Meeting via Webex to review current bills being proposed that affect the Law Enforcement Profession to take positions for the organization and Officers statewide.
- 11) This month, I had a zoom meeting with Karema Dean from Archive Social which is a company that we contract with to archive our social media accounts for FOIA request fulfillment. The purpose involved getting the General Township and Marina Accounts administrators changed properly to the Clerk's office.
- 12) I conducted one staff meeting this month to review open case files discuss operations common to all.
- 13) I attended the Roscommon County Law Enforcement Administrator's lunch meeting held at Fred's Restaurant in Roscommon to discuss coordination with the area Department heads.
- 14) Lt Muszynski, Julie Hill, and I attended an overview meeting held by Honor Security and Supervisor Udy to learn the operation of the general Township camera system and security features.
- 15) The Department aided the Roscommon County Area Ministerial Association's monthly COVID-19 Food Distribution to supply safe traffic pattern and control for the event.
- 16) I attended another Small, Rural, Tribal BWC grant online seminar to discuss the progress and handling of digital evidence.
- 17) Additionally, our department was selected as one of 22 agencies in the Country to participate in a peer group to help set best practices for future grant recipients.
- 18) I met with several group users of the Northern Michigan Childrens Assessment Center for the purposes of meeting House Representative Ken Borton and a legislative Aide to Senator Bergman to promote the Center and to tour the future expansion square footage within the current CRAF Center.
- 19) I chaired a regular meeting of the Northern Michigan Children's Center Board to conduct the business of the center.
- 20) I attended the Roscommon County Emergency Management Planning team meeting held in County Building Room 101 as a member of the team.
- 21) This month, School Resource Officer John Wybraniec attended a Behavioral Threat Assessment Management training with a contingent of Roscommon Area Public Schools Administrators.
- 22) Lastly, School Resource Officer John Wybraniec and I attended the Michigan Commission on Law Enforcement Standards (MCOLES) Active Violence Standard Training as all Officers are required to attend for licensure. The training was held at the Charlton Heston Academy. We were one of the six agencies who had Officers attending from surrounding Counties. As of now, our entire Department has trained as required.
