Gerrish Township Police Monthly Report 11-01-23 through 11-30-23

The Gerrish Township Police Department responded to a total of 104 calls for service for November 2023.

The Department reports 4 total citations listing 2 traffic violations, 0 written verbal warning, 0 misdemeanor citations and 2 civil infractions. (See attached detailed report)

Training:

The Department reports 114 hours of training for this month. (See attached detailed document)

Chief Hill highlighted activity for the reported month is as follows:

1. 2023 Shop with a Cop Applications were distributed to area schools as we work towards another season of giving and sharing goodwill in our community. Sgt. Labonte coordinated and did the vetting of the applicants for the Shop with a Cop program. This year we adopted 5 full families to include 8 children and 8 adults. Chief Hill is also reaching out to the Northern Michigan Children's Assessment Center (NMCAC) to see if they have any other families that may need some aid this Holiday season. Shopping with families is scheduled to start December 9, 2023
2. I attended the Township Board monthly work session as required.
3. Lt. Muszynski and I attended the Gerrish Township regular monthly Board meeting as required.
4. Gerrish Township Public Safety will be ringing the bell for the Salvation Army at the Family Fare on 12-15-23 on behalf of their organization again this year, and we will ring at the Family Fare in Roscommon between 2:00 p.m.-7:00 p.m.
5. Once again, this year our Department is taking part in a three month "No Shave" campaign to help a Deputy's family from Oscoda County whose daughter has been diagnosed with cancer and given less than a year to live. Our Police Officers Association will be donating to the family at the end of the campaign.
6. Lt. Muszynski and I attended the ACT-NOW Executive Board Meeting.
7. I met with 5 new CERT candidates that are interested in joining the CERT Team as a member.
8. The Department is still preparing for the Department LEIN Audit of our CJIS information which is scheduled for December 13, 2023. This is done every three years.

9. The Department is preparing and planning a 20-hour CERT Basic class at the PD that will start on December 4, 2023, and go for 6 weeks. We have 5 new CERT members looking to join the team.
10. All Officers completed the LEIN Operator Test Section 1 & 2 which is needed every 2 years and is an area that will be looked at in the upcoming LEIN Audit.
11. Officer Ellis completed a 40-hour Evidence Technician Course at Delta Community College. With this training he will be able to process crime scenes completely and be a huge asset to the Department.
12. I conducted two staff meetings this month to review all open case files and statuses and go over our community projects on tap for November and December 2023. We also had training for Trauma Bleed Kits that we carry in the patrol cars and Stop Stick Training for our tire deflation devices.
13. We have been approved for the Training Certification Accreditation Program (TCAP) grant offered through the Michigan Township Participating Plan. We will be receiving 75% back of the cost of \$3150.00 once the accreditation process is complete.
14. We have finally taken possession of the 800 MHz Motorola radio for Car #3. We have been waiting for the radio since February of this year. The patrol car has been scheduled with Pro Comm in Mt. Pleasant to have the radio installed and we will then have a fully equipped patrol vehicle.
15. Our Police Cadet Alex Cole is scheduled to graduate from the Police Academy on December 8, 2023, and we have been preparing for his arrival.
16. Our Kids Helping Kids for Christmas shopping and wrapping was done this month to deliver our Christmas program for foster kids and their families.
17. I re-signed the NMCAC Roscommon County Partner Protocol for Child Abuse/Neglect and Criminal Sexual Conduct cases.
18. Gerrish Township CERT and Police Department helped once again this month with the Food Distribution that has been occurring monthly since the Covid-19 virus arrived. We work in partnership with the Roscommon Area Christian Ministries.
19. I attended the Michigan Association of Chiefs of Police Legislative and Executive Board meetings via a WebEx meeting format.
20. As the board chair of the NMCAC, I conducted a meeting of the board of directors for the NMCAC. Our meetings are a combination of Zoom and in person to accommodate each members wishes.
21. Also this month, I chaired several Capital Campaign meetings at the NMCAC to begin the process of the center's expansion project.
22. We are proud to continue and advertise our Gerrish Police Department mobile application.
23. Lt. Muszynski and I attended the monthly Roscommon County Law Enforcement Administrator's lunch meeting at Fred's of Roscommon.
24. The drug take-back for 6 months totaled 93.4 lbs. delivered to the Petoskey Department of Public Safety and the Tip of the Mitt Watershed Council for destruction. Our drug drop box is available 24 hrs. a day at the Police Department.
25. Lt. Muszynski aided with transporting the prescription drugs to Grand Rapids, Mi to be incinerated at a special facility that uses waste to create steam, which in turn powers a turbine to create power for part of Grand Rapids. A total of 3,520 lbs. (1.76 tons) of prescription drugs were taken to the facility.
26. All Officers were re-certified in CPR/AED this month to keep their licensure. The class was provided by CPR/AED instructor Administrative Clerk Julie Hill.

27. Administrative Clerk Julie Hill has completed a Virtual American Heart Association (AHA) Instructor Renewal course.
28. Lt. Muszynski met with Jason Jansen to help him with a Short-Term Rental complaint in the Highlands.
29. Lt. Muszynski, Officer Wybraniec, and Officer Stachurski aided the Messiah Lutheran Church with delivering food boxes to 20 community households.
30. Lt. Muszynski attended the LPT Board Meeting held at the Roscommon County Emergency Operations Building while the Chief was on vacation.
31. Lt. Muszynski, Sgt. Labonte, Administrative Clerk Julie Hill and I all met as Command Staff to delegate and diversify the needs for the future about Accreditation, Court Set Asides (CSA) and the redesign of the digital FTO program delivery software.
32. Administrative Clerk Julie Hill held a CPR skills session at the GTPD for a staff member of the Sundrop Montessori.
33. Lt. Muszynski and I met with Superintendent Shawn Petri from C.O.O.R. ISD. Shawn provided the Department with key fobs for their building as the exterior doors are now accessible with a key fob. Shawn also said that they are continuing to make improvements to the building and renovating more space they have. Shawn also said he is continuing to work with the road commission with new signage for their school zone and cross walk that was painted on the road.
34. The Department attended Lockdown drills at the Roscommon Area Public Schools (RAPS) Campuses to practice safety measures and name areas of improvement as needed within the Emergency Plan.
35. As always, this is a remarkably busy Community relations time for our department, and I thank my Officers for giving their time and efforts to support this time-consuming level of service. Additionally, we are so blessed and grateful for our volunteers now and throughout the year which help make it all possible.

In other news for upcoming events to note:

On December 18, 2023, at 5:00 p.m., we will be having our annual Shop with a Cop” WRAPPING EVENT” at the Police Department and we will be having pizza and beverages during the event.

The Police Department and ACT-NOW members will be delivering the Shop with a Cop gifts for Christmas on Wednesday, December 20, 2023, at 1:00 p.m.
