Q: When are my taxes due?

A: Summer taxes are due from July 1 to September 14 without penalty. Tax payments are still accepted through February 28 with interest. Interest amounts are as follows

- September 15-30, 1%
- October 1-31, 2%
- November 1-30, 3%
- December 1-31, 4%
- January 1-31, 5%
- February 1-28, 6%

Winter taxes are due from December 1 to February 14 without penalty. Tax payments are still accepted through February 28 with interest. Interest amounts are as follows

• February 15-28, 3%

Q: What if the 14th falls on a holiday or weekend?

A: Taxes will be due on the next business day.

Q: Where do I pay a delinquent tax bill?

A: Taxes that become delinquent as of March 1 must be paid at the Roscommon County Treasurer's Office. Call the Roscommon County Treasurer's Office at 989-275-5823 for a correct payment amount. Make checks payable and send directly to the Roscommon County Treasurer's Office.

Q: Can I write one check for multiple parcels?

A: Yes, you may write one check for multiple parcels providing they are for the same tax season (summer or winter). If you are paying both the summer and winter tax bills please write two (2) separate checks.

Q: Where do I send my tax payment?

A: Gerrish Township 2997 E. Higgins Lake Drive Roscommon Mi., 48653.

Q: Do you accept postmarks?

A: Yes, in order to avoid interest the envelope must be postmarked on or before the due date.

Q: I would like to receive a receipt?

A: Send a self-addressed stamped envelope along with your payment.

Q: What form of payment is accepted?

A: Cash, check or money order made payable to Gerrish Township. Credit Cards are accepted in the office only. NO over the phone credit card payments will be accepted.

Q: How do I change my address?

A: Address change forms are available on the township website under Treasurer or call the Treasurer's office at 989-821-9313.

Q: How do I change my name due to marriage or divorce?

A: You will need to send in a certified copy of the marriage certificate or divorce decree.

Q: How do you remove an individual from the tax bill/deed due to a death?

A: You will need to send in a certified copy of the death certificate.

Q: How do you add/remove an individual from the tax bill/deed?

A: You will need to file a new deed with the correct information. Gerrish Township recommends that you contact an attorney.

Q: Can I claim a special assessment payment on my income taxes?

A: Gerrish Township recommends that you contact your tax advisor.

Q: Why did I receive a tax statement when my property taxes are escrowed?

A: A tax statement is sent to the taxpayer for informational purposes. It informs the taxpayer of their taxable value, SEV and current tax amounts, which can be used for filling your income taxes. As the property owner you are responsible for making sure the taxes are paid. By receiving a tax statement you can verify that your mortgage company has requested the information. If we received a request from your mortgage company the tax statement states:
