Gerrish Township Police Monthly Report 02-01-17 through 02-28-17

The Gerrish Township Police Department responded to a total of 93 calls for service for the short month of February 2017.

The Department reports 10 various custodial arrest statistics this month. (See attached reports for breakdown).

The Department reports 30 total citations listing 31 traffic violations, 6 Misdemeanor violations and 14 verbal warnings issued for the month. (See attached for breakdown).

Training:

A total of 68 hours of contact training and 18 credit hours of on-line training are reported for this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the Michigan Association of Police Chiefs mid-winter conference and took various training classes to include training presentations from St. Louis County, Missouri Chief Jon Belmar regarding lessons learned after the shooting that resulted in widespread rioting for many days in their community. Additionally, I attended training classes in the following areas;

- Current litigation and discussion of Mental Health calls for service as nationally they are now 1 in every 10 calls received.
- Recruitment, hiring and retention was another topic presented to discuss strategies to combat this large problem in the police field.
- Public threat alerts and the new criteria for same.
- HIDTA (High Intensity Drug Trafficking Association) discussion on current Heroin epidemic and the need for a better network to track offenders and the connection lines from agency to agency.
- Religious accommodation at arrests and traffic encounters and the current cases that are applicable.

- I attended a leadership principles class and attended the Keynote address by a nationally known author Heather MacDonald who wrote a recent book entitled “The war on Cops” which discusses the national media narrative on our profession.
 - I also attended the MACP Executive Board Meeting in my Past President role as well as the Northern Michigan Chiefs of Police Assn. meeting held at the conference

- 2) I attended the Gerrish Township Board work session as required and updated the board on Department activities.
- 3) I attended the ACT-NOW Executive Board meeting in my advisory board member capacity to plan activities to benefit our community in 2017.
- 4) I attended two Gerrish Township Insurance committee meetings to hear presentations from the Township’s Insurance agent regarding Health Insurance proposals for the 2017-2018 year which begin May 1, 2017. The committee will then present affordable options to the Township board for action at an upcoming meeting to accommodate expiration and renewal dates.
- 5) Sgt Patchin and I met with Honor Security twice to discuss our 5 year old camera system in the parking lot and interview rooms as well as additional coverage on the area that touches the Compost site.
- 6) I coordinated with CERT for renewal of CERT members CPR cards.
- 7) I hosted and attended a department staff meeting for the purpose of recertification of Officers in the Law Enforcement Information Network training which is required every two years.
- 8) I attended two AVI planning meeting held in conjunction with the LEPC to develop and active shooter training to be conducted at the Roscommon County Courthouse.
- 9) I worked the 2017 Higgins Lake Winterfest Cardboard classic by providing Unit 241 on standby on site for potential injuries and transport.
- 10) I assisted with a Drug dog sweep of the Roscommon High School as requested by the Roscommon Area Public Schools.
- 11) I attended the Child Death Review team meeting as I am on the team that reviews all child deaths in the County to identify and make recommendations regarding prevention possibilities that could be explored to abate possible future deaths.


