GT Zoning Ordinance (ZO) regulations pertaining to official high-water marks, seawalls, and retainer walls for lakeside properties were discussed. 2. Gill-Roy's Sign (Art. 9). Gill-Roy's hardware store chain recently submitted plans to the GT BZA (Jansen) to open a new store in the building (formerly used by the current Knights of Columbus) located at 165 W. Federal Hwy, Roscommon, MI. In accordance with the GTZO, a Site Plan is not required for this new business and proposed construction. However, they have submitted a variance request to the GT Zoning Board of Appeals for the construction of their store-front sign, currently scheduled to be heard on Feb 1, 2021 (GTZBA 21.01). BUILDING & ZONING (B&Z) ACTIVITIES (Administrator Jansen): 1. Lots of ongoing B&Z activities in the Township, with one variance request from Gill-Roy's as noted above. 2. There has been no further action taken by Dollar General to proceed with their conditionally approved Site Plan (GTPC meeting Jul 9, 2020) to build a new store on Robinson Rd. 3. A couple upcoming Site Plan Review applications are currently being prepared for submission. GERRISH TOWNSHIP BOARD UPDATE (Commissioner Newton): Terry Newton and Mary

Jo Oppy were elected and recently sworn in as the new GTB Trustees, replacing Mary Link and James
Lippert, respectively. ZONING BOARD OF APPEALS CONCERNS (Commissioner Briggs): Six ZBAs were held
since the last GTPC meeting (20.3, 4, 6, 7, 8, & 9. 20.5 was cancelled). Nine ZBAs were conducted during
the 2020 calendar year, compared to thirteen held in 2019. OPEN LINE: Nothing significant to report.
