Gerrish Township Police Monthly Report 06-01-22 through 06-30-22

The Gerrish Township Police Department responded to a total of 193 calls for service for the month of June 2022.

The Department reports 6 custodial arrest statistics for this listed period. (See attached report for breakdown).

The Department reports 17 total citations listing 13 traffic violations, 5 Misdemeanor violations, and 4 written warnings for this listed period. (See attached for breakdown).

Training:

81 training hours are reported during this listed period. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I attended the ACT-NOW Executive Board meeting in my Advisory role.
- 2) I attended the Gerrish Township Board work session as required to update the board on the operational status of the Department.
- 3) The Department hosted 2 days of First Aid classes for the second quarter CERT training initiative.
- 4) I met with area Law Enforcement partners regarding the South Higgins Lake State Park for the purposes of discussing the Fourth of July potential activity at the park and a needs assessment for an enforcement effort at the park this year. We reviewed the data from past years, and it was determined that no formal task force with a Unified command would be deployed. The partners agreed to put overtime patrol units in the area to be able to respond quickly, however we would have very limited Officers in the Park to walk the area as in past years. As the Chief, I authored an Operations Plan with a contingency to be able to augment personnel and provide an overall command as well as a communication plan should one become necessary.
- 5) I attended the Gerrish Township Board regular meeting as required.
- 6) I attended one Roscommon County Law Enforcement Command meeting held at Fred's of Roscommon.
- 7) I attended a Gerrish Township ARPA organizational meeting to set up a process for the Township as it relates to distributing ARPA funds in a formal manner. Additionally, we reviewed grant requirements and discussed investment categories to properly book keep the funds.

- 8) I met with Lt Muszynski and Administrative Clerk Julie for the purposes of discussing the 2023-2024 budget construction in anticipation of a meeting with the board on June 17, 2022.
- 9) Subsequently, I attended and presented the proposed 2023-2024 budget with the Gerrish Township Board. No changes were requested by the board in anticipation of an August public hearing.
- 10) I attended a MACP Legislative Meeting in my role as a member of this committee that reviews and assesses positions on current legislation that effects Law Enforcement in Michigan. This meeting was held via an electronic media as well.
- 11) I also re-worked our Release of Evidence and Property policy to reflect statute adjustments.
- 12) I met with a few citizens this month regarding various concerns regarding ORV's and Air B & B and VRBO short term rentals and their associated social problems that they can present to our community.
- 13) The Department, Fire/EMS, CERT and ACT-NOW assisted with the running of the Higgins Lake Sunrise Run 1 mile, 5k, 10k and half marathon this month. The event was conducted without incident. The event handled about 250 runners between the four runs.
- 14) This month saw a technology upgrade in Officer Zachary Stachurski's desk-top computer.
- 15) The Department provided Incident Command for the continued Food Distributions being held at the Roscommon Area Public Schools Bus Garage. There are several partners that we work with to accomplish these each month. The Gerrish Township CERT team helps us provide the necessary traffic direction and flow to keep all visitors in their cars.
- 16) I attended the Summer MACP Professional Development Conference this month. Several leadership topic breakout sessions were taken.
- 17) This month, I had Environmental Pest Control at the Police Department to spray for large spiders that we have found in the building as well as the small black millipedes that invade our garage area every year.
- 18) I met with the NMCAC Executive Director for the purposes of preparing an agenda for a special work session meeting of the Board of Directors regarding pay/benefits schedule and Policy manual organization and additions.
- 19) In line with above, the NMCAC Board met and worked through the topics listed above in item #18.
- 20) I met with Supervisor Udy regarding Township legal issues.
- 21) I attended the NMCAC multi-discipline team meeting to review all cases of child abuse/neglect and sexual assault that went through the center this month.
- 22) Administrative Clerk and CPR/AED/First Aid instructor conducted two Heartsaver First Aid Classes for the CERT members and members of the Police Department as required. 9 people were re-certified. Additionally for the community/partner, she conducted a Heartsaver First Aid CPR/AED Skills session for 2 Roscommon County Juvenile Detention Center employees.
- 23) I attended a LEPT meeting to discuss emergency planning for Roscommon County as a Law Enforcement representative.
- 24) I conducted one staff meeting this month where we reviewed open case files, summer Riparian, PA 56 of 2012 Enforcement processes and other locations of usual public interest at lake sites.

The ACT-NOW/GTPD Golf Outing fundraiser will go on as planned on August 13, 2022, at the Redwood Golf Course with a 9:00 a.m. registration and 10:00 a.m. shotgun start. This is our largest fundraiser for our benevolent projects. Please join us and bring your friends!
