Gerrish Township Police Monthly Report 07-01-23 through 07-31-23

The Gerrish Township Police Department responded to a total of 168 calls for service for the month of July 2023.

The Department reports 40 total citations recording 37 traffic violations, 3 Misdemeanor violations, 2 written verbal warnings, 1 Public Act 56 Violation. (See attached report for breakdown)

The Department also reports 5 custodial arrests for the monthly period. (See attached report for breakdown)

Training:

The Department reports 16 hours of training this month as we tend to the greater population of summer residents. (See attached breakdown)

Chief Hill highlighted activity for the reported month is as follows:

- 1) I authored and attended the Police Department's Monthly work session update and delivered same at the meeting.
- 2) I attended the ACT-NOW Annual Board Meeting and picnic in my Advisory role capacity. The meeting and picnic were held outdoors at the Gerrish Township Community Park and Marina, and we were joined by 72 Citizens for the event.
- 3) I prepared the July Monthly Board Reports as required for the July Regular Township Board meeting.
- 4) The Department provided traffic safety and Incident Command for the July 22, 2023, Monthly Food Assistance held at the RAPS Bus garage in collaboration with the Roscommon Area Christian Ministries organization and the DHHS.
- 5) I attended the July ACT-NOW Executive Board meeting in my Advisory role.
- 6) I attended the Northern Michigan Children's Assessment Center multi-discipline Case Review Team meeting held at the NMCAC.
- 7) Lt Muszynski and I attended the monthly Roscommon County Law Enforcement Administrators meeting held at Fred's Restaurant in Roscommon.
- 8) I was contacted about providing a person and vehicle for the Bud Bash 2023. Operations plan to be administrated by the Sheriff Department at the Bud Bash 2023.

- 9) I conducted one Staff meeting this month that centered on case review, supervision and management of our files and the workflow.
- 10) I chaired one Executive Board meeting for the NMCAC in my chairperson role to formulate a budget for the new fiscal year for the center.
- 11) I also attended a sustainability Committee meeting for the NMCAC to begin exploring marketing needs and options as the center embarks on a Capital Campaign to expand the footprint and service model of the center.
- 12) I attended the regular Gerrish Township Board meeting as required.
- 13) Lt Muszynski and I met with Brad Gibson of the Sheridan Drive Association to work through some recreational trespass issues that happened near the St Louis Road end. We have discussed a reasonable strategy moving forward to address the issue that occurred over the 4th of July.
- 14) Lt Muszynski and I also met with the St Louis Road end dock permittee to discuss the activities described in #13 and asked for her assistance in locating and identifying the violating parties so that the PD could educate the parties prior to any enforcement activities. The permittee and a resident she brought with her to meet us were very cooperative and provided enough information for us to solve the issue for the future in a cooperative fashion.
- 15) Lt Muszynski conducted a policy violation of work rules investigation and turned same over to me for addressing with an employee. I counseled and formally wrote a written reprimand to one Officer this month for a violation of our work rules.
- 16) Lt Muszynski and I attended a Law Enforcement debriefing that I had requested to discuss the 4th of July 2023 activity at the South Higgins Lake State Park. The July 4th day turned out terribly busy and at times overwhelmed the staff that were dedicated to this year's plans. Highlighted were fights, assaults, alcohol, drugs, and dehydration issues. Over capacity issues were discussed as well as what we could do next year to better protect our Enforcement/EMS. We also finished the meeting with an ask to meet with the Parks District Supervisor or other above the Park Manager level. Park Manager Roberts was going to pursue that request. We all agreed to meet again.
- 17) I met with COOR Superintendent Shawn Petri, RCRC Manager Roger Saxton and Neil Balenger PE at the COOR Administrative building for the purpose of discussing the COOR Schools request for a crosswalk and school zone on Co Rd 101. In the meeting it was determined that a school zone was within statute request and the RCRC was going to move ahead with the design phase and measurements to determine the empirical speed and distances that the zone would incorporate.
- 18) The Small Rural Tribal Grant Federal Grant Administrators requested me to be interviewed about our usage of the recently awarded body worn camera grant so they could feature in their newsletters for future awardees as best practices and policies regarding their use. I submitted to the 30-minute interview via telephone and received a copy of the subsequent article for review before publication.
- 19) This month, we embarked upon a Mobile Application (App) project specific to the GTPD and its operations. The App will be individualized and once built will be available for free download in the App store for Apple and will also be available on Google Play for Android phones. The App will tie our website information, social media accounts and other resource direction for our community together. We have started the design and build phase and more will follow.
- 20) I chaired and attended the 911 Technical Advisory Committee meeting this month for the purposes of assisting the 911 Dispatch Center in its operations and policy.
- 21) Lt Muszynski, Admin. Assistant Julie Hill, and I attended the Township Hall security Training session as requested by the Township Supervisor.
- 22) I attended the Roscommon County Emergency Planning Committee meeting held at the Roscommon County EOC.

23) This month, we replaced the 8 ft center bay garage door as same was dented and developed cracks. Additionally, we replaced the bottom seals to the other two 16 ft bay doors. This service was done by JM Door of Grayling, Mi.

24) The whole Department attended the hands-on training with the new Intoxilyzer 9000 that is being deployed as the next generation of Breath Test Instruments in Michigan. We also took three other on-line classes earlier this year as a pre-requisite to be certified to run these instruments.

25) This month, I addressed the Annual Meeting of the Higgins Lake Property Owners Association as requested to discuss the various enforcement concerns around the lake. I took several questions, and I was appreciative of the opportunity to address the group.

26) As a follow up later in this month of July, we were able to get a meeting of the next chain of command for the park systems. District Supervisor of the Parks and the Regulatory director of the Parks met with our debriefing group to discuss the frustrations, challenges etc. of the park on the 4th of July. Many topics were discussed in a great open and respectful way. Some suggestions made will be taken back to the next layer of command of the parks to discuss and we all agreed to meet again in three months to check everyone's progress working on the issues.

27) I attended the Child Death Review Team meeting which was held to discuss two child deaths in the County that occurred May 2023. The group attempts to make sure that anything preventative that could have been done was done. Additionally, we recommitted our resources to the Child Death Investigative Team concept to investigate these deaths collaboratively as it takes a certain set of skills to conduct the proper investigation needed.

28) In order to further a succession plan for my retirement, I have instituted a monthly command meeting where I will expose the command team to policy writing, monthly responsibilities, some management book readings, and assignments each month.

29) Lastly, I attended the Sexual Assault Nurse Examiners quarterly meeting to check in on the status of the program staffing, statistics, and operation to benefit my Officers in knowing the correct procedures to access the program with Sexual Assault Victims.

In other news,

This summer continues to be remarkably busy with many visitors. Mental health calls for service seem to be abound as well as civil disputes between neighbors. Parking continues to be a large problem around the South Higgins Lake State Park during weekends when it is hot and access to the lake is sought. ORV and improper use of same has certainly permeated our area and we continue our enforcement efforts. The primary enforcement is for no underage operation, staying on the shoulder of the road and traveling less than 25 mph as provided for by County ORV Ordinance #4.

We are happy to announce that John Ellis was once again voted as the new Chairperson for the ACT-NOW Executive Board for 2023-2024. John has a great energy about him with a selfless attitude. Additionally, John is an active CERT team member who is always there when we call. We applaud and thank John for stepping up to this role. The rest of the board remained intact. I thank them all immensely for their partnership and intense interest in the quality of life in our community.
