ANNOUNCEMENTS:

On December 18, 2018, the Roscommon Area Public Schools passed a resolution to impose a summer property tax levy in Gerrish Township. In July 2019, the RAPS millages will be taken off of the 2019 winter tax bill and will be placed on the 2019 summer tax bill. Residents whose property is 100% homestead will not see much of a change. Those residents whose property is non-homestead will see a reduction in the winter tax bill and an increase in the summer tax bill. You will still pay the same amount, but you will be billed differently. If you have any questions regarding the change call the RAPS Superintendent's Office or a school board member.
