Gerrish Township Police Monthly Report

08-01-24 through 08-31-24

The Gerrish Township Police Department responded to a total of 126 calls for service for August 2024.

The Department reports 11 total citations listing 9 traffic violations, 3 written verbal warnings, 2 misdemeanors and 2 custodial arrests. (See attached for breakdown).

Training:

The Department reports 14.5 hours of training this month. (See attached breakdown)

Chief Muszynski highlighted activity for the reported month is as follows:

- 1) I attended the monthly Gerrish Township Board work session as required and briefed the board on Department operations for August 2024.
- 2) I attended the monthly ACT-NOW Executive Board meeting in my Advisory role to conduct the business for same.
- 3) In August, Administrative Clerk/CPR/AED Instructor Julie Hill supplied a CPR/AED class for RAPS teachers/coaches/staff as asked. Second, she did a CPR/AED Skills Session for 1 Mid-Michigan Health Services staff member and 1 RES staff member here at the PD.
- 4) Lt. LaBonte, Administrative Clerk Julie Hill and I attended a virtual MCOLES Lunch and Learn. Several key topics were covered and it was very educational.
- 5) I attended the Roscommon County monthly Law Enforcement Administrator meeting held at Fred's Restaurant in Roscommon, Mi.
- 6) I prepared a budget and presented same at the Police Department Special Assessment Public Hearing as needed for our 2025-2026 budget year.
- 7) I also reviewed the above budget and trained Lt. LaBonte on the construction of the same as well as how it would be presented to the board and public at the public hearing.
- 8) This month, Supervisor Hill, RCRC Manager Roger Saxton, RCRC Foreman Dave Thompson and I met with a citizen to discuss a leaning tree on Carmen Avenue. The citizen is concerned the leaning tree is going to fall on his house and cause damage.

- 9) Lt LaBonte attended the Kirtland Community College Academy Advisory Board Meeting in my place as an advisory member.
- 10) On the Community front, the GTPD/ACT-NOW 15th Annual Golf Fundraising event (our largest fundraiser) was held on August 10, 2024, at 10:00 a.m. at the Redwood Golf Course. We had 22 teams participate and enjoyed 24 sponsors to the event. A huge thank you to all as we netted \$6,027.31 for our Act-Now projects.
- 11) Sgt. Wybraniec and Officer Ellis provided BTAM (Behavioral Threat Assessment and Management) training for the RAPS staff as school is back in session this month.
- 12) School has resumed and Officer Ellis will be the SRO (School Resource Officer) this year.
- 13) I attended the regular Township Monthly Board Meeting this month.
- 14) In August, we supplied one Officer and Patrol unit to the cooperative Enforcement effort of the Annual Bud Bash in Houghton Lake. We do this as they aid us on our 4th of July Enforcement at the South Higgins Lake State Park. There was a marked decrease in issues experienced this year.
- 15) We held one Command Meeting and one Staff Meeting this month.
- 16) Also on the Community front, we have had an organizational meeting of the Trunk or Treat 2024 committee. Plans are in place to have same at the Township Complex this year for a face-to-face event. It will remain on October 31, 2024, and begin at 6:30 p.m. and go to 8:00 p.m. It is a Thursday this year. Pre-registration of trunk participants will be encouraged as in the past and they will have access to the field at 4:30 p.m. for set up. We will have the three main prizes (TBA) and ten random drawings for the trunk participants. Watch for flyers and our Facebook/website and App as more details are to follow.
- 17) I attended the NMCAC Multidiscipline case review for the purposes of reviewing CSC and Abuse/Neglect cases in the County that the NMCAC supplies services for.
- 18) Administrative Clerk Julie Hill and I met Trisha Meyers from U.S. Department of Veterans Affairs for resource sharing via our Police App/Website and Facebook.
- 19) The Department took part in the National Night Out held in the Village of Roscommon. Officer Cole attended for our department. Officer Cole stayed with the department Ranger #241 to answer questions about its uses. Gerrish Township CERT members also participated with the CERT trailer.
- 20) The department and GT CERT continue to aid the monthly RCAM with the delivery of the Food Distribution at the Roscommon Area Public Schools with a drive through method.

In other news,

- The Department Law Enforcement Special Olympics local Torch Run will be on September 10, 2024, with registration at 5:00 p.m. at the Gerrish Township Police Department. The run will begin at 6:00 p.m. sharp and travel from the Police Department to the South Higgins Lake State Park Gazebo, at the boat basin. Food will be available at the conclusion of the run and transportation from the Gazebo back to the Police Department is being

provided by the RAPS transportation department. Please come and join us for the run. There is a fee of \$30.00 which entitles the run/walk or bikers to a 2024 Torch Run shirt. All proceeds go to the Special Olympics of Michigan with half of our locally raised funds going to our local Area 4 Special Olympics athletes to off-set their costs to go to the Michigan Special Olympic games.
