1. Sanitation fee Schedule Discussion.

Clerk Squires prepared a spreadsheet of costs for the last 2 fiscal years and projected costs for the next fiscal year. GFL increase of \$6.14 per parcel, looking at \$225.00 per parcel for budget year 2025-2026. County has a proposal, but nothing has been approved for Materials Management. More discussion at work session.


