Gerrish Township Police Monthly Report 08-01-25 through 08-31-25

The Gerrish Township Police Department responded to a total of 160 calls for service for August 2025.

The Department reports 4 total citations listing 2 traffic violations, 1 civil infraction 1 written verbal warning, 1 misdemeanor and 1 custodial arrest. (See attached for breakdown).

Training:

The Department reports 23.5 hours of training this month. (See attached breakdown)

Chief Muszynski highlighted activity for the reported month is as follows:

- 1) I attended the monthly Gerrish Township Board work session as required and briefed the board on Department operations for August 2025.
- 2) I attended the monthly ACT-NOW Executive Board meeting in my Advisory role to conduct the business for same.
- 3) In August, Administrative Clerk/CPR/AED Instructor Julie Hill supplied a CPR/AED class for RAPS coaches and support staff as asked.
- 4) Administrative Clerk Julie Hill and I attended a Zoom meeting with Cost Recovery Corp to go over their new billing.
- 5) Administrative Clerk Julie Hill and I continue to meet with Power Policy to learn this new platform for Gerrish Township Police Department.
- 6) I prepared a budget and presented same at the Police Department Special Assessment Public Hearing as needed for our 2026-2027 budget year.
- 7) SRO Sgt. Ellis attended a reunification walk through of the Roscommon County Road Commission facility.
- 8) SRO Sgt. Ellis attended a fire drill at the The Sundrop School.
- 9) SRO Sgt. Ellis attended a training on Responding to and Investigating Bomb Threats and Swatting Hoaxes that was put on by FBI Boston and Massachusetts State Police.
- 10) The Police Department parking lot was also used a drop location for a Scrap Tire Clean Up collection site that was in partnership with CHA.
- 11) I attended the Kirdand Community College Academy Advisory Board Meeting as an advisory member.

- 12) The Police Department also assisted the Roscommon County Sheriffs Department with traffic control for the Annual Houghton Lake Pumpkin Run Car Show.
- 13) Administrative Clerk Julie Hill attended a Zoom meeting for our Police Department App to learn new ways to promote same.
- 14) On the Community front, the GTPD/ACT-NOW 16th Annual Golf Fundraising event (our largest fundraiser) was held on August 9, 2025, at 10:00 a.m. at the Redwood Golf Course. We had 19 teams participate and enjoyed 32 sponsors to the event. A huge thank you to all as we netted \$6,596.26 for our Act-Now projects.
- 15) SRO Sgt. Elks provided BTAM (Behavioral Threat Assessment and Management) training for the RAPS staff as school is back in session this month.
- 16) School has resumed and SRO Sgt. Ellis will be back in the schools with the students and staff this year.
- 17) SRO Sgt. Elks attended the RHS open house and also attended the RAPS District Open House which included RES, RMS and RHS.
- 18) I attended the regular Township Monthly Board Meeting this month.
- 19) In August, we supported one Officer and Patrol unit to the cooperative Enforcement effort of the Annual Bud Bash in Houghton Lake. We do this as they aid us on our 4th of July Enforcement at the South Higgins Lake State Park. There was a marked decrease in issues experienced this year.
- 20) I held one Command Meeting and one Staff Meeting this month.
- 21) I attended 2 Rotary Lunches held at Fred's of Roscommon.
- 22) The Gerrish Township Police Department Parking lot was cracked sealed/seal coated and lines repainted this month along with the rest of the GT Complex parking lots.
- 23) The Department took part in the National Night Out held in Downtown Saint Helen. Officer Most attended for our department. Officer Most stayed with the department Ranger #241 to answer questions about its uses. Officer Stachurski also attended National Night Out as a Child Passenger Safety Technician. Gerrish Township CERT members also participated with the CERT trailer.
- 24) The department and GT CERT continue to aid the monthly RACM with the delivery of the Food Distribution at the Roscommon Area Public Schools with a drive through method.

- The Department Law Enforcement Special Olympics local Torch Run will be on September 9, 2025, with registration at 5:00 p.m. at the Gerrish Township Police Department. The run will begin at 6:00 p.m. sharp and travel from the Police Department to the South Higgins Lake State Park Gazebo, at the boat basin. Food will be available at the conclusion of the run and transportation from the Gazebo back to the Police Department is being provided by the RAPS transportation department. All proceeds go to the Special Olympics of Michigan with half of our locally raised funds going to our local

Area 4 Special Olympics athletes to off-set their costs to go to the Michigan Special Olympic games. Come join us!
